

3. This statement by Senator Roy may have been what Q was referencing. Not sure why he'd have "BLUNT" in all caps though.



5. The 666 drop in the stock market was the Cabal's way of showing POTUS they are in charge. Guess we'll see about that!







10. Q is asking anons to "find the roll" (1 of 4 videos - find the 4th?) of the #SOTU. Enhance, spread, make it go viral.





The video cameras inside the house chamber are not owned or operated by CSPAN. The house also forbids any news network to bring their own cameras inside the chamber. The cameras inside the house chamber are owned and operated by the house itself; specifically the House Recording Studio. Since there are, I believe, 4 camera feeds operating in the chamber - I believe Q wants us to view the RAW footage on Feed 1. This must be obtained offline through The Clerk of the House.
