





9. Here's another side-by-side SC/LL tarmac deal graphic by an anon with connections to more past Q drops that Q approves of.





10. An anon noted that @realDonaldTrump didn't use a question mark re: LL being offered a seat on the





11. Q posted a photo that appears to be in China (Bank of China sign in bottom left corner) and says it is "The WHERE". Not sure what "The WHAT" is yet....






12. This photo, which anons quickly traced to the Shenzen Stock Exchange builidng in China, is what Q is calling "The WHY".














14. An anon noted that it was not the Bank of China but rather the China CITIC Bank in Beijing, China in Q's "The Where" drop. Not sure of the connection yet.






