During this time, we also honor the brave men and women who selflessly respond to crises and disasters, rendering aid to those in need. 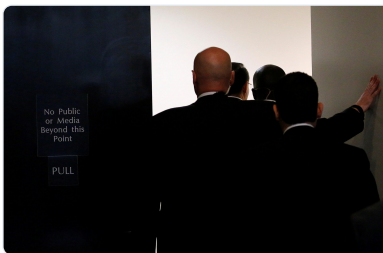


