Although the company believes it has taken appropriate steps to remediate identified activity, users should exercise caution and follow best practices in order to protect personal e-mail and prevent the compromise of government and personal information." It then recommended best practices for Department users and their family members to follow, including "avoid conducting official Department business from your personal e-mail accounts."<sup>142</sup>
