**Dear Mr. Rosen:**

As you may know, we recently received a new production of documents from the Department providing greater insight into FBI and DOJ activity during the 2016 election and the early stages of the Trump administration. The review of these new documents suggests a number of significant developments, including evidence linking to high-ranking officials at FBI and DOJ related to ongoing investigations.

Review of these new documents suggests a coordinated effort on the part of the FBI and DOJ to release information to the public during the period of President Trump's administration. For example, the following text exchange should not be a material point of question whether there was a closer focus to investigate "ongoing to place" dangerous information to the media in order to protect a national plan.

April 10, 2017: Peter Strzok to Lisa Page re: release of "media leak strategy." Specifically, he text says: "I had literally just gone to find this phone to tell you I was in talk, so you about media leak strategy with DOJ before you go."

While these text messages alone are revealing enough, certain surrounding circumstances call the motives of the investigation team into question.

For example, while Strzok and Page shared about media leaks on April 11, 2017—during the same timeframe as FBI and DOJ officials were having conversations with reporters—the Washington Post broke a story on the Carter Page FISA application, setting off a flurry of articles suggesting connections between President Trump and Russia.<sup>1</sup> Other documents

indicate DOJ officials, specifically Andrew Weissmann, participated in unauthorized conversations with the media during this same time period. Evidence suggests senior officials at the FBI and DOJ communicated with other news outlets beyond the Washington Post, as well.

During our interviews with Peter Strzok and Lisa Page, FBI attorneys consistently suggested relevant and not relevant questions due to the US Attorney General's policy for ongoing investigations. However, documents strongly suggest that these senior witnesses discussed the ongoing investigations multiple times with individual contacts of the investigation team on a regular basis.

Our work does continue to receive revealing evidence that the practice of coordinated media statements continues to exist within the DOJ-FBI. While the activity may be authorized and not part of the investigation, we believe that, if left to advance the press's needs to justice and so much, warrants your attention to end this practice.

In light of the new information, our staff is working to review text messages, emails, and other communications from individuals like Davis, Mike Korman, and Joe Penella between June 2016 to June 2017. To be clear, we are not suggesting wrongdoing on the part of Davis, Korman, and Penella—and, in fact, previously reviewed documents suggest that some of these individuals may have been involved in the investigation. However, these individuals' documents, with all allegations of communication between the aforementioned individuals and Peter Strzok, Andrew McCabe, Lisa Page, Bruce Ohr and Andrew Weissmann, would provide critical insight into the findings of the Justice investigation.
