U.S. Attorney General Loretta Lynch, who leads the U.S. Department of Justice that was a party in the lawsuit challenging the law, praised the appellate panel for striking down a law "that the court described in its ruling as 'one of the largest restrictions of the franchise in modern North Carolina history." Lynch described the law as one that placed "barriers between citizens and the ballot box."

"And it sent a message that contradicted some of the most basic principles of our democracy," Lynch said in her statement. "The ability of Americans to have a voice in the direction of their country – to have a fair and free opportunity to help write the story of this nation – is fundamental to who we are and who we aspire to be. Going forward, the Department of Justice will continue our work to protect that sacred right for all."






Figure 3.1: FBI Chain of Command for the Midyear Investigation
