





# Gang of Eight (intelligence)







For the group of US Senators who wrote a comprehensive immigration reform bill in 2013, see Gang of Eight (immigration). For other uses, see Gang of Eight.

The **Gang of Eight** is a colloquial term for a set of eight leaders within the United States Congress who are briefed on classified intelligence matters by the executive branch. Specifically, the Gang of Eight includes the leaders of each of the two parties from both the Senate and House of Representatives, and the chairs and ranking minority members of both the Senate Committee and House Committee for intelligence as set forth by 50 U.S.C. § 3093(c)(2) E.

Under normal conditions, the President of the United States is required by Title 50 U.S.C. § 3091(a)(1) to "ensure that the congressional intelligence committees are kept fully and currently informed of the intelligence activities of the United States, including any significant anticipated intelligence activity as required by [the] title." However, under "extraordinary circumstances", when the President thinks "it is essential to limit access" to information about a covert action, 50 U.S.C. § 3093(c)(2) allows the President to limit reporting to the Gang of Eight.

Trump told anchor Sean Hannity that his lawyers previously had advised him not to take that dramatic step out of fear that it could be considered obstruction of justice.

"I do, I have plans to declassify and release. I have plans to absolutely release," Trump said. "I have some very talented people working for me, lawyers, and they really didn't want me to do it early on. ... A lot of people wanted me to do it a long time ago. I'm glad I didn't do it. We got a great result without having to do it, but we will. One of the reasons that my lawyers didn't want me to do it, is they said, if I do it, they'll call it a form of obstruction."

Trump added: "Frankly, thought it would be better if we held it to the end. But at the right time, we will be absolutely releasing."

Trump also accused FBI officials of committing "treason" -- slamming former FBI Director James Comey as a "terrible guy," former CIA Director John Brennan as potentially mentally ill, and Democrat House Intelligence Committee Chairman Adam Schiff as a criminal.






