




Clare Bronfman sentencing 25 July for her role in NXIVM.

Clare Bronfman Pleads Guilty in Nxivm 'Sex Cult' Case, Leaving Leader to Stand Trial Alone

The Seagram's liquor heiress was one of two women who pleaded guilty on Friday in a racketeering case against the cultlike group that branded members.




