

Dear Attorney General Frosh,

I respectfully request that the Maryland Attorney General's Office investigate potential abuse and missue of a Maryland nonprofit through its coordination with a Maryland corporation. The comportic Center of Golda Policy Solomon ("Center"), Insophin the fee-profit Global Policy Solitions, LLL ("CGPS"), agrees to provide an improper financial benefit to Ms. Maya Rockeymore Cummings and her harband, Representantic Elijah Cummings. As part of your mission to protect citizen douations to legitimate enopoint organizations, this situation requires oversight and mevingation to ensure that these entities are operating in accordance with the law.

The Center and GPS bear a strikingly close resemblance. Ms. Rockeymoore Cummings serves as the principal officer and is the sole staff member listed on the Center's website. McKexpmoore Cummings is also the sole owner and only staff member listed for GPS. The entities share the same phone number and the same address.


