

In **typography**, **kerning** is the process of adjusting the spacing between characters in a **proportional font**, usually to achieve a visually pleasing result. Kerning adjusts the space between individual letter forms, while **tracking** (letter-spacing) adjusts spacing uniformly over a range of characters.<sup>[1]</sup> In a well-kerned font, the two-dimensional blank spaces between each pair of characters all have a visually similar area.

The related term **kern** denotes a part of a type letter that overhangs the edge of the type block.<sup>[2]</sup>

Not taking care of something so simple as this can ruin your credit for you when you get out. If you have a financed car, try to sell it. Many ex-prisoners face bankruptcy when they get released because they don't focus on these issues beforehand.<sup>[2]</sup>

- In some states, your bank may be able to provide a line of credit to cover your time in jail. This can be applied to your mortgage, car payments, and many other financial issues. Talk to your bank to see if there is anything they can do to make your transition in and out of jail easier on you.
