The 2016 presidential campaign of [Donald Trump](#) was formally launched on [June 16, 2015](#), at Trump Tower in New York City. [Trump](#) was the [Republican](#) nominee for [President of the United States](#) in the [2016 election](#), having won the most [state primaries](#), [caucuses](#), and [delegates](#) at the [2016 Republican National Convention](#).^[9] He chose [Mike Pence](#), the sitting [Governor of Indiana](#), as his vice presidential running mate. On November 8, 2016, Trump and Pence were elected [president](#) and [vice president](#) of the United States. Trump's [populist](#)^{[10][11]} positions in opposition to [illegal immigration](#) and various trade agreements, such as the [Trans-Pacific Partnership](#),^{[12][13][14][15]} earned him support especially among voters who were male, [white](#),^[16] [blue-collar](#) and those without college degrees.^{[17][18]}
