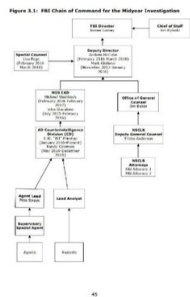

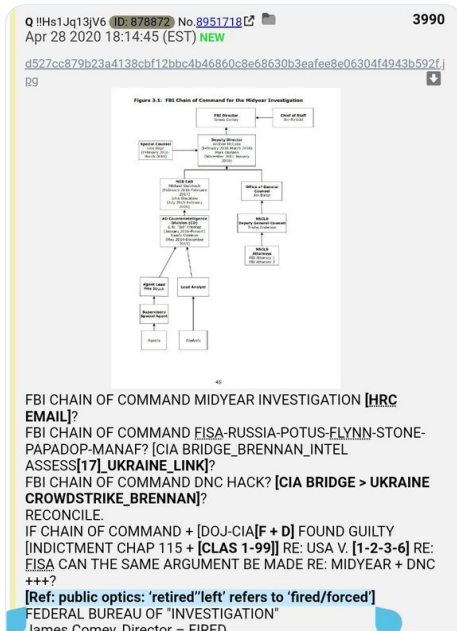

Under the "gang of eight" system, the Exec branch of the U.S. discloses highly sensitive intelligence information to specific positions within Congress.

Members are sworn to secrecy & there is no vote process [en.m.wikipedia.org/wiki/Gang\\_of\\_E...](https://en.m.wikipedia.org/wiki/Gang_of_Eight)

The **Gang of Eight** is a colloquial term for a set of eight leaders within the **United States Congress** who are briefed on classified intelligence matters by the executive branch. Specifically, the Gang of Eight includes the leaders of each of the two parties from both the **Senate** and **House of Representatives**, and the chairs and ranking minority members of both the Senate Committee and House Committee for intelligence as set forth by 50 U.S.C. § 3093(c)(2) [c](#).

Under normal conditions, the President of the United States is required by Title 50 U.S.C. § 3091(a)(1) [c](#) to "ensure that the congressional intelligence committees are kept fully and currently informed of the intelligence activities of the United States, including any significant anticipated intelligence activities as provided by that title." So this video game — which is not a real game, for the record, and was clearly created for the show — plays an important part of the story "Jack Ryan" tells. If you're wondering whether that is actually a thing that terrorists do in the real world — using video games to communicate and coordinate — well, the answer is probably not.

If you've been hanging around on the internet for a while, you might think you've heard about Islamic terrorists using "World of Warcraft" or private messaging on PlayStation 4 to set stuff up. But, in fact, there is no publicly available evidence that terrorists have used video games as a way to secretly communicate.

***That time range is incredibly important*** because the conversation detailed knowledge and planning of events that had not occurred nor been reported at the time the conversation took place, meaning those participating in the conversation had first hand knowledge of events that wouldn't occur until hours later.
