Blizzard claimed that Chung violated the tournament's rules, which forbid players from making offensive statements or damaging Blizzard's brand. The decision sparked a fierce backlash from gamers, as calls to boycott Blizzard's products trended on social media and popular *Hearthstone* caster Brian Kibler announced that he would no longer participate in future Blizzard events.

Many gamers also accused Chinese tech giant **Tencent** (<u>OTC:TCEHY</u>), which owns a 5% stake in Activision Blizzard, of forcing the decision. Blizzard eventually backed down, agreed to return the prize money to Chung, and reduced his suspension. In a statement, Blizzard president J. Allen Brack admitted that the company "reacted too quickly" to Chung's remarks.

There's a particularly, hmm, "interesting" bit in the midsection of Amazon's new "Jack Ryan" series in which Suleiman (Ali Suliman) – the main villain in Syria – uses the chat feature in an online video game to communicate secretly with his brother (Haaz Sleiman) in France. Later, Jack Ryan (John Krasinski) tries to use the same game to trick Suleiman into revealing his dastardly plans by pretending to be that same brother.

So this video game — which is not a real game, for the record, and was clearly created for the show — plays an important part of the story "Jack Ryan" tells. If you're wondering whether that is actually a thing at terrorists do in the real world — using video games to communicate and coordinate — well, the answer is probably not.

If you've been hanging around on the internet for a while, you might think you've heard about Islamic terrorists using "World of Warcraft" or private messaging on PlayStation 4 to set stuff up. But, in fact, there is no publicly available evidence that terrorists have used video games as a way to secretly communicate.

# Deep State Private Chat Intercepted, Exposes A Coup Attempt Against America By Intelligence Community Members


On May 17, 2017, a person that calls himself "FreshCamel," posted messages on multiple forums across the Dark Web (part of the Internet not included in search engines and requires special encrypted programs to access it), asking for help to decipher a discussion he had witnessed between five people communicating using the secure messaging platform called Gliph. The same day, the user also uploaded four screen shot links to a pastebin account which allegedly showed the conversation "FreshCamel" witnessed on Wednesday, May 17, 2017, during a 45 minute period, from 2:31 pm to 3:15 pm.

That time range is incredibly important because the conversation detailed knowledge and planning of events that had not occurred nor been reported at the time the conversation took place, meaning those participating in the conversation had first hand knowledge of events that wouldn't occur until hours later.
