Dear Governor Murphy:

I am writing to make you aware of the attached letter I transmitted to the White House last evening requesting the removal of all extraordinary federal law enforcement and military presence from Washington, DC immediately. The New Jersey National Guard is one of the forces that were brought to the District of Columbia without my knowledge and not at my request.

I commend the guardsmen and women from New Jersey for rapidly mobilizing to answer the President's request. However, as we have increasingly seen in recent days their presence is unnecessary and may be counterproductive to ensuring the protests remain peaceful.
