PRECAUTIONARY STATEMENTS

Caution: May cause eye injury and skin irritation. Do not get in the eyes or on the skin. Wash thoroughly after handling. Wear protective gloves, clothing and eye and face protections.

DIRECTIONS FOR USE:

Shake product well before use. Mix product with at least 50 gallons/acre of water as a carrier. Spray as needed. Water in lightly afterwards to wash product into the crown and root zone.

SOIL APPLICATION RATES:

FOR INITIAL USE OR WHEN THERE IS NEMATODE ACTIVITY: 1-2 gallons/acre on Days 1, 15 and 30.
FOR MAINTENANCE USE: 1 gallon/acre monthly.

FIRST AID

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Sip a glass of water if able to swallow. Do NOT induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If not breathing, call 911 or an ambulance, then administer artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for further treatment advice.

IF ON SKIN OR CLOTHING: Remove contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store in a cool, dry area under lock and key. Post as a pesticide storage area. Always store pesticides in the original container. Store away from food, pet food, feed, seed, fertilizers, and veterinary supplies. Place liquid formulation on lower shelves and dry formulation above.

DISPOSAL: To avoid wastes, use all material in this container by application according to label directions. If wastes cannot be avoided, offer remaining product to waste disposal facility or pesticide disposal program (often such programs are run by state or local governments or by industry).

CONTAINER HANDLING: Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times then offer for recycling if available, or puncture and dispose of in a sanitary landfill or by incineration. Do not burn unless allowed by state and local ordinances.
