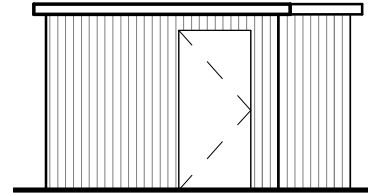
1 **Front-Shed**
