TAKE GA 400 NORTH
TAKE EXIT 6, NORTHRIDGE ROAD
FOLLOW EXIT RAMP AROUND TO THE RIGHT ONTO NORTHRIDGE ROAD
CROSS OVER 400
VEER RIGHT BEFORE THE LIGHT ONTO DUNWOODY PLACE
TURN LEFT AT THE 2ND LIGHT ONTO HIGHTOWER TRAIL
TURN RIGHT INTO THE 1ST PARKING LOT
WE'RE THE 1ST BUILDING, #8300
TAKE THE ELEVATOR TO THE 2ND FLOOR, SUITE 200

DIRECTIONS GOING SOUTH ON GA 400

TAKE GA 400 SOUTH
TAKE EXIT 6, NORTHRIDGE ROAD
AT THE LIGHT, GO STRAIGHT ACROSS NORTHRIDGE ROAD ONTO DUNWOODY PLACE
TURN LEFT AT THE 2ND LIGHT ONTO HIGHTOWER TRAIL
TURN RIGHT INTO THE 1ST PARKING LOT
WE'RE THE 1ST BUILDING, #8300
TAKE THE ELEVATOR TO THE 2ND FLOOR, SUITE 200

**DIRECTIONS FROM ROSWELL GOING SOUTH ON GA HWY 9,
USING DUNWOODY PLACE**

TAKE GA HWY 9 SOUTH & CROSS OVER THE CHATTAHOOCHEE RIVER
AT THE 1ST LIGHT, TURN LEFT ONTO DUNWOODY PLACE (THERE IS A BP GAS STATION
AND A BANK OF AMERICA ON THE CORNERS)
GO THROUGH THE LIGHT AT THE COCA-COLA PLANT
JUST PAST THE COCA-COLA PLANT, TURN RIGHT AT THE NEXT LIGHT, HIGHTOWER
TRAIL
TURN RIGHT INTO THE 1ST PARKING LOT
WE'RE THE 1ST BUILDING, #8300
TAKE THE ELEVATOR TO THE 2ND FLOOR, SUITE 200

**DIRECTIONS FROM SANDY SPRINGS GOING NORTH ON ROSWELL ROAD, USING
HIGHTOWER TRAIL**

TAKE ROSWELL ROAD NORTH
TURN RIGHT ONTO HIGHTOWER TRAIL (RUSTY NAIL & \$3 CAFÉ ARE ON THE CORNERS)
TURN LEFT INTO THE LAST PARKING LOT BEFORE THE DEAD-END INTO DUNWOODY
PLACE

TAKE THE ELEVATOR TO THE 2ND FLOOR, SUITE 200

DIRECTIONS FROM EAST COBB

TAKE UPPER ROSWELL ROAD (GA. HWY. 120) TO THE ROSWELL SQUARE AND TURN
RIGHT (SOUTHBOUND) ON ATLANTA ROAD
ATLANTA ROAD TURNS INTO ROSWELL ROAD SOUTH OF THE CHATTAHOOCHEE RIVER
AT THE 1ST LIGHT, TURN LEFT ONTO DUNWOODY PLACE (THERE IS A BP GAS STATION
AND A BANK OF AMERICA ON THE CORNERS)
GO THROUGH THE LIGHT AT THE COCA-COLA PLANT
JUST PAST THE COCA-COLA PLANT, TURN RIGHT AT THE NEXT LIGHT, HIGHTOWER
TRAIL
TURN RIGHT INTO THE 1ST PARKING LOT
