# **TERMS OF USE & SERVICE**

#### 1. GENERAL

- 1.1 The following Terms of Use and Service apply to the products and services provided by **RoadWIZARD Pty** Ltd (ACN 620 776 356).
- 1.2 In this document, the words "the Service" refer to http://truckwiz.co and the Truckwiz and Tones Truckin App Software Application, and "we", "our", "us" and "Truckwiz and Tones Truckin App" refers to RoadWIZARD Pty Ltd (ACN 620 776 356), the operator of the Service and all of its related entities. This Terms of Use applies to and should be read in conjunction with the Privacy Policy (collectively, the 'Agreement'), which is available at http://truckwiz.co.
- 1.3 By using or accessing the Services, you ("you") agree to all the terms and conditions of the Agreement, and if you do not agree to all the terms and conditions of the Agreement you should not and are not permitted to use the Services.

# 2. MODIFICATIONS TO THE AGREEMENT

- 2.1 Truckwiz and Tones Truckin App reserves the right in its sole discretion, to modify the Agreement at any time by posting a revised Agreement to the Service. Please carefully read the Terms of Use & Service and check back often. If you do not agree to any change to the Terms of Use & Service then you must immediately stop using the Service.
- 2.2 Modifications are effective when posted, and your use of the Services following any such posted modification and notice of same constitutes your acceptance of the terms and conditions of this Agreement as modified. Any changes made after you have placed an order will not affect that order unless we are required to make the change by law.

# 3. SERVICES OFFERED

- 3.1 The Service is a service which facilitates the communication of information between drivers of large and commercial vehicles.
- 3.2 The Service may contain errors and inaccuracies and we reserve the right to correct any errors or inaccuracies and to update information at any time without any notice.

# 4. CAUTION

- 4.1 Road information prevails. The information provided by the Service is not intended to replace the information provided on the road, such as travel direction, time based restrictions, lane restrictions, road blockades, traffic signs, traffic lights, police instructions, etc.
- 4.2 Cautious driving. Always drive vigilantly according to road conditions and in accordance with traffic laws. It is strictly forbidden to send traffic updates (such as updates on road accidents and traffic congestion), or to non-verbally interact with the Service or use the Service in a non-verbal manner for any purpose other than navigation while driving. Traffic updates or non-verbal reports you want to submit to the Service may only be sent after you have stopped your vehicle in an appropriate location permitted by law. Alternatively, such updates may be sent by a passenger other than the driver, provided it does not interfere with the due course of driving and does not distract the driver's attention to the road.

### 6. PRIVACY

- 6.2 If you provide any information to us, either intentionally or incidentally about any other person through your use of the Services, including but not limited to medical or health information about that third party, you:
  - 6.2.1 if that third party is a minor, agree that through your use of the Services you consent to the collection and use of this information; and
  - 6.2.2 if that third party is a minor, give permission for that third party to consent to the collection and use of this information;
  - 6.2.3 if that third party is not a minor, warrant that the third party has reviewed and consents to these Terms and Conditions; and
  - 6.2.4 if that third party is not a minor, warrant to TruckWIZ that the third party has reviewed and consents to the Privacy Policy.
- 6.3 We collect personal information about you in order to process your registration and provide you with services and for purposes otherwise set out in our Privacy Policy.
- 6.4 We may disclose that information to third parties that help us deliver our services (including information technology suppliers, communication suppliers and our business partners) or as required by law. If you do not provide this information, we may not be able to provide all of our services and products to you.
- 6.5 We may also disclose your personal information to recipients that are located outside of your country.

# 7. ACCOUNT CREATION

- 7.1 In order to use the Service you will be required to provide your personal details. In particular, you must provide your real name, phone number, e-mail address and other requested information as indicated. You may be required to provide payment details that you represent and warrant are both valid and correct and you confirm that you are the person referred to in the billing information provided.
- 7.2 All information provided to us must:
  - 7.2.1 be accurate and correct to the best of your knowledge; and
  - 7.2.2 not infringe on the rights of any third parties, including but not limited to, content that infringes on privacy rights or intellectual property rights, such as copyright and trademark rights.
- 7.3 Upon successful completion the sign up process, we will provide you with an account, accessible for you by a password of your choice.
- 7.4 When you register and activate your account, we will provide you with a user name and password. You are responsible for keeping this user name and password secure and are responsible for all use and activity carried out under this user name.
- 7.5 If you are under the age of 13 years, you may not create an account or register as a member. If you are 13 or older but under the age of 18, you represent that you have reviewed these Terms with your parent or legal guardian to make sure that you and your parent or legal guardian understand these Terms.
- 7.6 If you are a parent or guardian permitting a person under the age of 18 (a Minor) to create an account, you agree to:
  - 7.6.1 exercise supervision over the Minor's use of the Services and account;

# 8. LIMITATIONS OF USE

- 8.1 You may not do any of the following while accessing or using the Services:
