Utilizing tools of Appropriate Dispute Resolution we provide Mediation Services for First and Second Cause Eviction Filings. The Court Mediation Program provides neutral third party facilitation between Landlords and/or Agents and Tenants facing eviction, prior to eviction hearings.

The benefit of this program is that agreements established through Mediation prevent, in most cases, an eviction judgement issued against the tenant (s), while providing both parties more input into the outcome of their case.

SMALL CLAIMS MEDIATION

There are benefits for plaintiffs and defendants to participate in Small Claims Mediations. If you are the defendant and you lose in court, the court will enter a judgment against you, which will show on your credit report and could hurt your credit. In mediation, you can reach an agreement with the plain tiff and there will not be a court judgment entered against you, so your credit will not be affected.

If you are the plaintiff and win in court, getting paid can be very difficult and you may have to spend more money and time. If you reach an agreement through mediation, you will not need more court hearings, and the other side is more likely to pay you because they were part of reaching that agreement and had a chance to really be involved in the resolution of the dispute.

Domestic Relations Mediation

Our Domestic Relations Mediation Program uses a Facilitative Mediation style that has a strong focus on Transformative Dialog, due to the ongoing relationship between parties, in most cases. Our Mediators are trained by the Ohio Supreme Court in Advanced Family Mediation and Domestic Abuse Awareness.
