

# **PRIVACY POLICY AGREEMENT**

Updated: February 15, 2020

Think Of Michael, Inc. (also referred to as Think Of Michael and The Think Of Michael Foundation) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Think Of Michael, Inc. of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time **Think Of Michael**, **Inc.** decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether to permit the use of their information in this separate manner.

This Policy applies to **Think Of Michael**, **Inc**. (and its DBA, **The Think Of Michael Foundation**), and it governs any and all data collection and usage by us. Through the use of **https://thinkofmichael.org**, you are therefore consenting to the data collection procedures expressed in this Policy.

Please note that this Policy does not govern the collection and use of information by companies that **Think Of Michael, Inc.** does not control, nor by individuals not employed or managed by us. If you visit a website that we mention or link to, be sure to review its privacy policy before providing the site with information. It is highly recommended and suggested that you review the privacy policies and statements of any website you choose to use or frequent to better understand the way in which websites garner, make use of and share the information collected.

Specifically, this Policy will inform you of the following:

- 1. What personally identifiable information is collected from you through our website;

- Voluntarily provided information which may include your name, address, email address, billing and/or credit card information etc. which may be used when you purchase products and/or services and to deliver the services you have requested, or to make donations and pay for event sponsorships. PayPal is the third party used to process payments on our website and they have their own privacy policy and protection procedures that we are not responsible for in any way. Think Of Michael, Inc. DOES NOT collect your payment information online nor does it store such information for any reason. If purchasing tickets to an event on our website through a link, we are not responsible for maintaining your information as that is also handled by a third party. Eventbrite (or any third party ticketing business we may use) is responsible for tickets and taking any payment information on their website links. We are not liable or responsible for any information shared with third party sites or businesses.
- Information automatically collected when visiting our website, which may include cookies, third party tracking technologies and server logs.

In addition, **Think Of Michael, Inc.** may have the occasion to collect non-personal anonymous demographic information, such as age, gender, household income, political affiliation, race and religion, as well as the type of browser you are using, IP address, or type of operating system, which will assist us in providing and maintaining superior quality service.

**Think Of Michael, Inc.** may also deem it necessary, from time to time, to follow websites that our users may frequent to gleam what types of services and products may be the most popular to customers or the general public.

Please rest assured that this site will only collect personal information that you knowingly and willingly provide to us by way of surveys, completed forms, and emails. It is the intent of this site to use personal information only for the purpose for which it was requested, and any additional uses specifically provided for on this Policy.

## Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To better understand your needs and provide you with the services you have requested;
- To fulfill our legitimate interest in improving our services and products;
- To send you promotional emails containing information we think you may like when we have your consent to do so;
- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;
- To customize our website according to your online behavior and personal preferences.

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

### **Use of Information Collected**

Think Of Michael, Inc. does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

**Think Of Michael, Inc.** may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <a href="https://thinkofmichael.org">https://thinkofmichael.org</a>.

**Think Of Michael, Inc.** may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered, as well as to inform you of fundraisers, events, information about **The Foundation** and other relevant information.

Think Of Michael, Inc. uses various third-party social media features including but not limited to Facebook, Twitter, LinkedIn, Pinterest, Instagram, YouTube, Vimeo and other interactive programs. Other third parties we use are PayPal, Venmo, Eventbrite, Go Daddy, Salesforce as well as others that we may change at any time without notice. These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within Think Of Michael, Inc.'s control. We are not responsible or liable for any issues you may have with any third parties.

### **Disclosure of Information**

**Think Of Michael, Inc.** may not use or disclose the information provided by you except under the following circumstances:

- as necessary to provide services or products you have ordered;
- in other ways described in this Policy or to which you have otherwise consented;
- in the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Think Of Michael, Inc.

### Notice to European Union Users

**Think Of Michael, Inc.**'s operations are located in the United States. This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

The company also uses **Secure Socket Layer (SSL)** for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information.
