### IMPORTANT FINANCIAL DEADLINES FOR YOUR PTA UNIT

Proper financial procedures protect your PTA Unit's finances and ensure that your unit is in Good Standing. We have several important deadlines coming up in the next few months:

November 15th: for a PTA Unit to retain its tax-exempt status, they must file a 990N e-postcard with the IRS no later than the 15th day of the 5th month after your fiscal year ends. For the majority of our units, their fiscal year ends on June 30th, making this deadline November 15th. This is a very simple process; if your unit has taken in less than \$50,000 for the year just click <u>this link</u> and enter the EIN number and contact information for your unit. You will receive an email from the IRS verifying that your submission has been accepted and this verification should be sent on to Missouri PTA (officel@mopta.org).

**December 1st**: the <u>Year End Review</u> is prepared by the Treasurer and then 3 other people (cannot be signers on the bank account) review this and the books of the bank account. It can be filed online or printed, filled out and mailed to Missouri PTA.

The Year End Report is a summary of the fiscal year's expenses and receipts and the numbers should match the



## SUPPORT PROPOSITION H TO BENEFIT HAZELWOOD SCHOOL DISTRICT

On November 8th, residents in the Hazelwood School District will have an opportunity to vote on a Bond issue, Proposition H. This is a \$130 million zero-tax-



rate change bond proposal and the money will go towards safety and security improvements, updates and renovations to athletic/activity facilities, classroom technology and network upgrades, purchase new school buses, and improve the energy-efficiency of facilities. Passage of the bond issue would not increase the district's debt service tax rate, which is used solely to fund construction and major repair and improvement projects in the district. A four-sevenths super-majority (57.14%) is required for approval of the bond issue.
