Ice Harbor Dam (U. S. Army Corps of Engineers), Walla Walla, WA – Ice Harbor Lock and Dam is a hydroelectric, concrete gravity run-of-the-river dam on the Snake River in Walla Walla and Franklin counties in Washington state. The dam is located 8 miles northeast of the town of Burbank and 12 miles east of Pasco, river mile 9.2. Construction began in June 1955. The main structure and three generators were completed in 1961, with an additional three generators finished in 1976. The spillway has ten gates and is 590 feet long.
