1. INTRODUCTION

Monere Investments, Inc. is registered with the Securities & Exchange Commission as a broker-dealer that provides brokerage accounts and services. The firm is also a member of FINRA, MSRB and SIPC. Brokerage and investment advisory services and fees differ; it is important for you to understand the differences. 2. WHAT INVESTMENT SERVICES AND ADVICE CAN YOU PROVIDE ME?

- The brokerage services we provide include buying and selling securities and recommending investments to
 retail investors. You may purchase almost any product available to individual investors. However, some
 products may have additional restrictions on purchase or associated cost. Monere Investments currently
 does not offer any propriety products. We generally do not recommend illiquid products such as no-traded
 REITS or Private Placements.
- We have requirements for opening an account, including required paperwork and verification of your
 personal information. We generally do not have account minimums, but we cannot guarantee proper
 diversification of investments with limited assets.
- We can offer you additional services to assist you in developing and executing your investment strategy and monitoring the performance of your account. We are not required to monitor your portfolio or investments on an ongoing basis unless agreed to in advance. Your financial professional should review your accounts at least annually. Monere Investments, Inc. and its employees cannot take responsibility for circumstance beyond our control. For that reason our ability to monitor your investments may have limitations, including but not limited to: changing interest rates, after hours trading, overseas markets, governments and local central banks that may impact your investments.

3. FEES, COSTS, CONFLICTS, AND STANDARD OF CONDUCT

3A. What Fees Will I Pay?

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

- The fee you pay is based on the specific transaction and not on the value of your account.
- With stocks or exchange-traded funds, the fee is usually a separate commission. With other investments, such as bonds, this fee may be part of the price you pay for the investment (called a mark-up or mark-down). With mutual funds, a fee typically called a load reduces the value of your investment. Mutual funds also charge annual management fees which vary depending on the fund. With certain investments such as variable annuities, you may have to pay fees such as surrender charges to sell the investment, reducing the value of your investment.
- We may charge you additional fees such as custodian fees, account maintenance fees, and account inactivity fees.

- The more transactions in your account, the more fees we will charge you. We therefore have an incentive to encourage you to engage in transactions.

3B. What are your legal obligations to me when providing recommendations? How else does your firm make money and what conflicts of interest do you have?

When we provide you with a recommendation, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the recommendations we provide you. Here are some examples to help you understand what this means.

- We may buy and sell your investment through our own accounts (called "acting as principal") and we can earn a profit on these trades.
- We can make extra money by selling you certain investments either because they are managed by someone related to our firm or because they are offered by companies that pay our firm to sell their investments. Your financial professional also receives more money if you buy these investments.
