Event held rain or shine | Free admission to the public

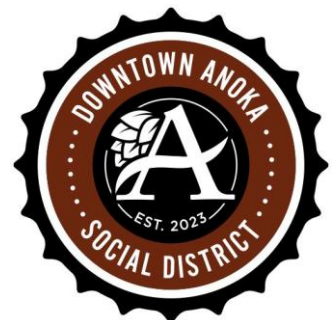
- Booth sizes will vary. See application for details.
- All items for sale should be vintage or antique. Early 90's or older. **NO crafts** but upcycled vintage welcome.
- All vendors are responsible for their own tables, chairs, displays, and sun/wind/rain protection.
- All vendors are encouraged to use canopies. It is strongly advised to use canopy weights for wind protection.
- Electricity is available in some booth locations for an additional \$25.
- Previous year vendors have priority sign up and placement.
- No refunds will be given if the event is canceled due to severe inclement weather, or any other reason.
-All funds will have been spent on City fees, advertising, toilets, etc., or gifted to event charities.

Vendors must arrive between 6am and 8:30am. All vendor vehicles must be unloaded and removed from the event area by 8:45. No vendor vehicles will be allowed in the event area from 8:45-5pm.

Teardown starts at 5pm and must be completed by 7pm.

Specific set-up, teardown, and parking instructions will be provided before the event.

AVF will always be the first Saturday in October and the kick off to the month-long event that is Halloween in Anoka. It's FREE for customers to attend, bringing over 20k people to this one-day event. It all happens in Anoka's Social District in the heart of downtown Anoka.

Anoka Vintage Fest is a vintage and antique market event. All items should be from the early 90's or older. **NO crafts** but upcycled vintage welcome.

The vendor agrees to be set up and ready for the event to start by 10am. Vendors should have enough merchandise on hand to sustain the event and will participate in the event for the duration of its scheduled time.

The vendor will only occupy their assigned area and will keep the sidewalk and street clear of tripping hazards.

Booths may not be sold or transferred to another vendor. If you need to cancel, contact event officials ASAP.

Booths larger than 10x10 may be shared, but each vendor must complete an application.

The vendor promises to leave their area the way they found it and clean from any debris. Not over filling trash bins.

The vendor agrees to pay their booth fee within 72 hours of receiving their application acceptance email. No refund will be given under any circumstance. As all funds for the event will have been allocated to produce the event.

Be advised per state law all vendors must collect and maintain records of Minnesota sales tax. Current rate is 8.125%.

Anoka Vintage Fest and the operators of this event will not be held liable for any loss, injury, damage, or legal action taken against a vendor regardless of the cause while the vendor is conducting business at the event. Security measures, theft prevention, and liability for the vendors merchandise is the responsibility of the vendor. Security will be on site throughout the event.

By signing and returning this application, you the vendor, agree to pay the booth fee and participate in Anoka Vintage Fest, but only if this application is approved by the event officials. The vendor also understands and agrees to abide by the rules, regulations, and instructions set forth in this contract, and any future instructions provided for day off. Failure to do so may result in the vendor's denial for attending any future events.
