## **The Following Rules Must Be Met to Participate in the Show**

1. By submitting your registration, you are declaring that you are the owner of all koi entered and that your koi has been in **your personal care for a minimum of 60 days prior to the show.**
2. You agree to accept the decisions of the Benching Team regarding size and variety.
3. You further declare that all koi entered in the Koi Show are free from and have not been in contact with KHV and are parasite free. Fish indicating any signs of illness will be disqualified.
4. You further declare that you are a hobbyist, not involved in the purchase and sale of Koi for business or profit.
5. You also agree to be present during the benching of your entries. At the completion of benching and photographing of your koi an "Official Benching Form" will be presented for your approval and signature. All potential disagreements must be satisfied at this time.
6. It is understood within the industry that transporting and exhibiting live Koi has its risks which could include damage and potential death. By signing and submitting your Exhibitor Form A you agree to expressly release the Upper Midwest Koi Club and its members, the St. Louis Park ROC and all its agents from any and all liabilities for damage, injury or loss which may arise from participating in this event.
7. You will be required to provide your own show bowl and proper koi net.
8. **All tanks have strict maximum points limits using the fish load formula.**
  - 6 foot tanks can hold a maximum of 30 points.
  - 8 foot tanks can hold a maximum of 50 points.
9. NO EXHIBITOR WILL BE ALLOWED WITHIN THE INTERIOR OF THE SHOW RING. IF ANY EXHIBITOR HAS CONCERNS ABOUT HIS/HER KOI ENTERED IN THE SHOW, EXHIBITOR AGREES TO ALERT SHOW STAFF PRIOR TO TAKING ANY STEPS UNKNOWN TO THE IN-RING STAFF.
10. Departure time for out-of-town exhibitors may begin at 11:30. Departure time for local exhibitors may begin at 1:00 pm.
11. All major award winners must remain in the tanks, unbagged, until departure time.

The Upper Midwest Koi Club accepts Koi into their show on behalf of the entrant, and while every care and precaution will be taken towards all Koi entered, the organizers cannot be held responsible for any loss or damage to Koi entered. No Koi shall be removed until the time decided for departure, unless there is a problem with a particular fish/tank or permission has been given from the show chair.

## Form A: Koi Show Awards and Sponsorship

All koi are eligible for awards in multiple categories. Awards designated by "A" can only be won by wagoi Kohaku, Sanke and Showa koi. All other varieties (including doitsu and ginrin Kohaku, Sanke and Showa) are in the category B. All judging decisions are final and not subject to dispute.

**Fish Load Formula**

Please follow these guidelines to ensure your fish remain healthy and stress free. For the safety of your fish, tank load limits will be strictly enforced. If your tank is overloaded, you will be asked to purchase an additional tank.

Use the following table to determine your total fish load points and the number of tanks needed.

For example,

If you bring five koi to exhibit, two size 5 koi and three size 4 koi, your total fish load points are:  $2 \times 5 + 4 \times 3 = 22$  points. Therefore, one 6' tank will be sufficient.
