Vendor Spaces

General: We anticipate at least 15 booth spaces, 10' x 10'. Both Dry and Wet vendors can be accommodated. Booth location assignments will be made by the UMKC board.

Electricity: Power is available but must be requested on the vendor registration form. Vendors will need to supply their own extension cords.

Tables: One (1) table is provided at no charge. Please indicate on the vendor registration form if one is required. Chairs are **not** provided though may be available on request.

Wet Vendors: Bio security will be strictly enforced for the safety of all exhibitor koi and all vendor koi on site.

- Additional tanks may be requested at a cost of \$50.00 each.
- Water quality is the exclusive responsibility of each individual vendor. Water is provided through the venue but vendors will need to bring their own hoses to prevent contamination.
- Vendor is responsible for providing any extension cords, pumps, air pumps, nets, bowls, dechlorinator, covers, bags and anything else necessary to sustain livestock and promote sales.
- One wet vendor tank is included for customers purchased koi size 3 and under

Insurance: Vendors are required to have insurance to cover both your employees and owners during the show and agree to hold harmless and indemnify both St. Louis Park ROC and the Upper Midwest Koi Club for any injury that may occur.

Loss Prevention: Our show is free and open to the public. The Upper Midwest Koi Club assumes no responsibility for lost or stolen products. Loss prevention is the exclusive responsibility of the vendor.

Refunds: If a vendor wishes to cancel, a refund of 80% of your registration fee will be allowed if notice is received by 5 days before the show.

Koi Show Awards and Sponsorship

All koi are eligible for awards in multiple categories. Awards designated by "A" can only be won by wagoi Kohaku, Sanke and Showa koi. All other varieties (including doitsu and ginrin Kohaku, Sanke and Showa) are in the category B. All judging decisions are final and not subject to dispute.
