1. Information on how to enter the Competition forms part of these terms and conditions of entry. Participation in this Competition is deemed acceptance of these terms and conditions of entry.

3. The Competition commences at 6am 1st June 2024 & finishes at 12pm 29th June 2024 ('Promotional Period').
4. The promoter of this Competition is Hughenden Freight & Industrial ABN 81196346996
5. Number of entries: multiple entries are permitted by customers during the duration of the promotion.
6. Entrants must be permanent residents of Queensland to be eligible to enter. Freight costs to get prizes to winners outside of the Flinders Shire area are not included.
7. If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions prevail.

COMPETITION

1. People may enter the competition by purchasing in store or over the phone from Hughenden Freight & Industrial. Each prize has its own entry criteria as per below.
