

## ARTICLES OF INCORPORATION OF FAIRVIEW ACRES LATERAL WATER USERS ASSOCIATION, INC.

RNOW ALL MEN BY THESE PRESENTS; That we, the undersigned, all of whom are of full legal age and bona fide residents and citizens of the United States, and of the State of Idaho, and who take water from the same canal known as the Davis Ditch have this day voluntarily associated ourselves together for non-profit sharing cooperative the purpose of forming a fater Users Association, pursuant to Section 30-1001 Idaho Code of 1947, and we do hereby certify as follows; to-wit:

I

That the name of this association is the Water Users Association of Fairview Acres Lateral, Inc.

TT

That the purpose for which and for any of which this association is formed are:

- 1. To buy, rent, sell or exchange water taken out of the Boise River and conveyed through a common ditch and lateral or laterals to the various property owners on what is known and designated as Fairview Acres in Ada County, Idaho.
- 2. To construct, maintain, build, repair such laterals and ditches as may be necessary for the proper conveyance of water from the same point of diversion, to the end that all users of such water may have an equitable distribution of such water.
- 3. To elect or appoint a lateral manager and fix his compensation and the election and compensation of all officers of said Association; to provide the levy of assessments necessary for the repair, maintenance, improvement and construction of laterals and distribution ditch or ditches; to

provide for the method of collection of such assessments and to do all and everything necessary for the proper operation of said Association pursuant to Chapter 13 of Title 42 of Idaho Code for 1947.

- 4. To do any and all things herein set forth and in addition such other acts and things that are necessary or convenient to the attainment of the purpose of this Association, or any of them in so far as such acts are permitted to be done by a corporation organized under the laws of the State of Idaho.
- 5. That this Association is a non- profit sharing association and issues no stock but shall have the power to levy assessments under and pursuant to Title/Chapter 13 Idaho Code of 1947.

## III

That the term of existence of the Association shall be perpetual.

## IV

That the location and post office of principal office in the State of Idaho shall be Boise, Ada County, Idaho.
