Pursuant to Section 715.72 of the Ohio Revised Code, notice is hereby given that a public hearing concerning the creation of a joint economic development district (the "JEDD") by the Township of German ("German"), Township of Jackson ("Jackson"), City of Germantown ("Germantown"), and the Village of Farmersville ("Farmersville") pursuant to a contract (the "JEDD Contract") to be entered into among German, Jackson, Germantown, and Farmersville all in Montgomery County, Ohio, will be held by the Board of Trustees of German, the Board of Trustees of Jackson, the City Council of Germantown and the Village Council of Farmersville at 1:00 o'clock p.m. on the 6th day, November, 2021, at Valley View Junior High School, 202 Jackson Street, Farmersville, OH 45325. At such time and place a hearing allowing for public comment and recommendations on the JEDD Contract and the JEDD will be allowed to all interested parties.
