# THE GERMAN TOWNSHIP BOARD OF TRUSTEES

The regular meeting was called to order at 7:00 P.M., at the Township Hall, 12102 S.R. 725 West, Germantown, Ohio, by Board President Randy Benson with the Pledge of Allegiance. Trustees Randy R. Benson, Benjamin F. DeGroat, Gregory A. Hanahan, and Fiscal Officer Robert W. Rohrbach Jr. were present. Road & Service Superintendent Jeremy Holbrook and Police Chief W. L. Wilcox were also present.

This meeting was digital tape recorded and the CD is on file. The Germantown Press, Dayton Daily News, and Middletown Journal were notified of the meeting.

## PUBLIC HEARING -

Mr. Benson introduced the Public Hearing to consider the zoning district changes as propose by the German Twp. Zoning Commission Case # 2011-01ZC. The changes to numerous parcels are outlined on the draft German Twp. Zoning Resolution Map dated November 9, 2010. These changes will bring changed parcels more into line with land use and surrounding zoning districts. The changes will also eliminate the problem of parcels split by two zoning districts.

Mr. Benson inquired if any of the visitors were there to testify in the public hearing. All stated no, but had questions and no one was sworn in:

Mr. Steve Dunham stated his 12 acre lot was proposed to go to R-1 from ½ R-1 and ½ Agriculture. He asked what restrictions would apply under R-1 in regards to a kennel, having cows, etc. He also stated he had spoken with Mrs. L. Rohrbach regarding this question and was advised that there would be no issues on R-1 of 10 acres or more.

Mr. Byrd asked why the properties went from Agricultural to R-1; that many residents prefer Ag. to R-1.

At 7:12 PM, Mr. DeGroat introduced a **MOTION**, seconded by Mr. Hanahan, to open Public hearing for case #2011-01ZC.

Mr. Boldt asked if everyone was being changed to R-1?

Several present asked why affected property owners were not notified by mail of the potential changes.

Mr. Hanahan reiterated the intent of the change and explained the notifications were completed in compliance with the current Zoning Resolution; that due to the large number of impacted properties, notification via newspaper was done. At 7:19 PM, Mr. Hanahan introduce a **MOTION**, seconded by Mr. Benson, to continue the hearing until 7:00 PM on April 11, 2011, the next regular board meeting; to allow the Board to obtain further information.

- Mr. Byrd requested an update on potential water projects for the Eby Rd. area.
  - Mr. Hanahan explained and provided an update about the Valley View Water & Sewer District activities. He explained that Eby Rd. area was on the list of potential projects, but no timetable has yet been established.
- II. Representative Henne asked the Board if they had any issues for his office. He updated the Board regarding various potential/pending legislation, including SB-5. He asked that any suggestions regarding the proposed budget and how it affects Townships be forwarded to him for review and discussion by the House.

- VI. Mr. Rohrbach informed the Board of a request by a resident Becky Kinner, to use the Township Hall for a Jewelry Party on May 13, 2011. The Board discussed the appropriateness of using the building for a forprofit party.

After discussion, Mr. DeGroat introduced an MOTION, seconded by Mr. Hanahan, not to lease the use of the Township Hall for "for-profit" events by residents. After discussion, all present voted in favor, MOTION passed. Ms. Kinner will be notified of the denial.

VII. Mr. Rohrbach reminded the Board of the upcoming Local Government Official Conference hosted by the Auditor of State in Columbus.

Mr. DeGroat introduced a **MOTION**, seconded by Mr. Benson to authorize attendance and pay expenses to the Local Government Conference of elected officials and department heads. After discussion, all present voted in favor, MOTION passed.

## PRESIDENT REPORT -

 Mr. Benson reported on Fire Oversight activities. A pay increase for weekend standby coverage by firefighters was approved by Oversight.

Mr. Rohrbach opened a discussion regarding the EMS levy.

Previously in the levy process, discussions were started regarding setting up a separate EMS levy oversight agreement to handle these levy funds.

Funds have started to arrive; the Board has created a separate levy fund to allow for receipt and distribution of these funds; but an EMS oversight agreement has not been created to manage these funds. Another option would be to modify the existing fire agreement to address the EMS funding.

- II. Mr. Benson reported that a Pool Oversight meeting was scheduled for Wednesday. He also noted that the Village has re-hired the pool management company used last year.
- III. Mr. Benson also reported that the Village of Germantown is conducting a

# POLICE REPORT -

- I. Chief Wilcox reported on the installation of the street light near the Township Hall entrance. The Board discussed the current location of the installed light. It does not adequately light the entrance to the Township Hall. Chief Wilcox will continue to work with Miami Valley Lighting to correct the issue.
- II. Chief Wilcox reported that the Fraudulent Document seminar sponsored by GTPD was very successful
- III. Chief Wilcox reported that Sgt. Andzik has successful completed the Ohio Association Chief's of Police College of Law Enforcement Executives.
- IV. Chief Wilcox commended Aux. Officer Ron Comer for completing in excess of 60 hours of volunteer work in February, creating and distributing a do's and don'ts of portable electric generator operation for all the residents of the Township.
  - V. Chief Wilcox updated the Board on the upcoming Commission Accreditation of Law Enforcement Agencies re-certification process. Assessors will arrive on April 2<sup>nd</sup> and leave on April 5<sup>th</sup>. A Board photo session will be held on April 4<sup>th</sup>. A Public Hearing will be held on April 4<sup>th</sup> at 7:00 PM.
  - VI. Chief Wilcox reported that Hunter Safety class held on March 5 & 6<sup>th</sup> had 20 participants with high test scores overall.
