The regular meeting was called to order at 7:00 PM., at the German Township Hall located at 12102 SR 725, Germantown, Ohio by Board Vice President Benjamin F. DeGroat with the Pledge of Allegiance. Trustees Jacob C. Stubbs and Benjamin F. DeGroat as well as Fiscal Officer Mark A. Keener were present. Trustee Randy R. Benson was absent. Police Chief Joseph Andzik and Road & Service Superintendent Jeremy Holbrook were also present. The audio of this meeting was digitally recorded and on file. The Germantown Press was notified of the meeting.

- I. Bob Rohrbach addressed the Board concerning some issues with absentee ballots being incorrect. The MCBOE was aware of the situation and was correcting it.
- II. Mr. Rohrback also updated those in attendance on the emergency radio drill that had been performed a week or two earlier. Amateur radio operators worked with Government officials to simulate a "grid down" situation to test communications. Mr. Rohrbach reported that the drill had been a success.
- III. Jack Holbrook informed the Board that he had purchased Crossroads Pizza and wanted to let those in attendance know what his plans are for the restaurant. He plans on making it a family oriented sports bar concept, similar to TJ Chumps in Miamisburg. He was also in the process of replacing the solid siding of the building with a lot of windows. He also informed the Board that he was applying for a liquor license for the establishment.
- IV. Joe Garrett addressed the Board on behalf of a company that he represents "Tribel". This company aggregates purchases of electricity and natural gas and passes the savings on to the citizens of the jurisdictions that approve this. Having Tribel provide these services would only be done after the passing of

- Township employee health insurance. She recommends keeping the existing coverage for another year. Although the cost is increasing by 11%, this is still the most cost effective option .Mr. DeGroat then introduced RESOLUTION 2015-058, seconded by Mr. Stubbs to retain the current employee medical insurance and to allow Health Insurance Coordinator Laurie Rohrbach to sign the agreements on the Township's behalf. After discussion, the adoption vote was as follows: Mr. Benson Absent, Mr. DeGroat Yes, Mr. Stubbs Yes. RESOLUTION 2015-058 passed.
- IV. Mr. Keener informed the Board that a new copy of the Ohio Revised Code had been received and placed in the Trustees' office. A short discussion on whether or not these were actually needed was held. Mr. DeGoat introduced a MOTION seconded by Mr. Stubbs to allow Mr. Keener to contact Mr. Ketter to determine if we were required by law to purchase these annually and, if not, to allow us to cancel the subscription, saving the Township \$205 each year. After discussion, MOTION passed.
- V. Mr. Keener deferred to Trustee DeGroat to give an update on the Valley View Water & Sewer District. The VVWSD Board had met earlier in the month and passed resolutions to dissolve the Board and assign the remaining debt not to exceed \$310,000.00 to Jackson Township and German Township. Mark Henry, attorney for VVWSD, is still working on the dissolution of the District. During the discussion, Greg Helmers asked questions concerning the dissolution. Those questions were answered by Mr. DeGroat. Pete Lurker pointed out that Jackson Township Trustees had approved a resolution at their October 11 meeting to accept responsibility for 40% of the remaining VVWSD debt.
- VI. Mr. DeGroat introduced **RESOLUTION 2015-059**, seconded by Mr. Stubbs, for the Township to assume 60% of the outstanding debt as owed by the Valley View Water & Sewer District. After discussion, the adoption vote was as follows: Mr. Benson Absent, Mr. DeGroat Yes, Mr. Stubbs Yes. RESOLUTION 2015-059 passed.
