- II. Mr. DeGroat reported that he'd met with several people concerning the school levy.

TRUSTEE STUBBS REPORT -

I. Mr. Stubbs reported that the pool had been inspected and that minor problems

- II. Mr. Stubbs reported that the Germantown Union Cemetary had paid the Township \$10,000 towards the purchase of the additional cemetery land.
- III. Mr. Stubbs attended the shred day and it was a big success.
- IV. Mr. Stubbs reported that the next meeting of the MCTA was going to be on May 19 at Washington Twp. He was planning on attending.

TRUSTEE CROSS REPORT -

- I. Mr. Cross suggested modifying the "Speakers Rules" for visitor comments.
 This is to ensure that all visitors are aware of the rules and that all visitors are treated consistently.
- II. Mr. Cross attended the Fire/EMS Oversight Committee.
- III. Mr. Cross introduced a **MOTION**, seconded by Mr. DeGroat, to continue participation in the Siren program. After discussion, **MOTION** passed.
- IV. Mr. Cross introduced RESOLUTION 2016-21, seconded by Mr. DeGroat, to support May 2016 as "Community Action Partnership Month". After discussion, RESOLUTION passed.

<u>POLICE REPORT – </u>

- I. Chief Andzik requested a **RESOLUTION** to approve the hiring of Edward Hammond as a Reserve Police Officer, subject to a one year probationary period. **RESOLUTION 2016-20** was introduced by Mr. Cross and seconded by Mr. Stubbs. After discussion, **RESOLUTION** passed.
- II. Chief Andzik requested a RESOLUTION to designate May 15th, 2016 as "Peace Officers Memorial Day". RESOLUTION 2016-22 was introduced by Mr. Cross and seconded by Mr. Stubbs. After discussion, RESOLUTION passed.
- III. Chief Andzik requested a **MOTION** to allow Adrea Johnston the right to use the German Township Meeting room for the purpose of conducting a Hunter Safety Class for youths on May 21/22, 2016. The **MOTION** was introduced by Mr. DeGroat and seconded by Mr. Stubbs. After discussion, **MOTION** passed.

- **IV.** Chief Andzik reported that the Shred Day held on May 7 collected 36 pounds of unwanted medication to be destroyed. Additionally, there were 15 "totes" of paper shredded. Chief Andzik thanked all those that participated and volunteered their time.
- V. Chief Andzik also noted that he had contacted Abundant Life Tabernacle and was setting up a "drug collection" date with them but it had not yet been set. He has also heard that the Church of the Nazarene was interested in a similar pick-up day, but he has not yet contacted them.

ROAD/SERVICE DEPARTMENT REPORT -

- I. Mr. Holbrook discussed "structure GE-654-0.68" a bridge culvert on Shimp Rd. The Road Department has started assembling materials for the replacement of the culvert. The pipe has been ordered and the concrete blocks for the end walls have been delivered.
- **II.** Mr. Holbrook reported that the first round of road side mowing has been completed.
- III. Mr. Holbrook reported that he attended the annual Engineer's Dinner and Yearly Report on April 20th.
- IV. Mr. Holbrook reported that the Road Department had removed two large ash trees on Keifer Rod. Both trees were dead and were starting to shed limbs on the roadway. The use of a man lift was donated by Ro-Lin Farms and Mr. Holbrook thanked them for this donation. This saved the Township approximately \$600.
- V. Mr. Holbrook also reported that six leaking skylights on the PD garage were replaced, the "Branham Lot" was split and that new pipes were installed on Stiver Rd.
