Dr. Cross led the group in the Pledge of Allegiance.

The announced purpose of the Special Meeting was:

• To consider the appointment of a full-time police officer.

POLICE OFFICER APPOINTMENT DISCUSSION:

Chief Andzik reported that Officer Nick Wolfe submitted his resignation in mid-May to pursue a law enforcement position in Georgia. He accepted Officer Wolfe's resignation on behalf of the Board of Trustees. He posted the full-time position with the part-time Reserve officers. He stated that Officer Josh Nichols applied and successfully meets the needs of the Police Department and the Township. Officer Nichols is a retired Navy veteran who also lives in the Township. He has been a Reserve officer for three years with the Township. Chief Andzik suggested that the Trustees hire Officer Nichols as a full-time, career officer. Due to his knowledge, experience and education, he suggested that Officer Nichols be hired at Step 3 on the Police Department's pay scale.

Mr. Stubbs noted that Officer Nichols does a great job. He is happy to have him become a full-time officer.
