ORGANIZATIONAL RESOLUTIONS AND MOTIONS:

Mr. Stubbs introduced RESOLUTION 2025-01, seconded by Mr. Potter: A RESOLUTION TO ESTABLISH THE 2025 SALARIES OF THE GERMAN TOWNSHIP TRUSTEES AND THE FISCAL OFFICER AT 100% OF THE ANNUALIZED AMOUNT ALLOWABLE UNDER THE OHIO REVISED CODE. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-01 WAS ADOPTED.

- Mr. Stubbs introduced RESOLUTION 2025-02, seconded by Mr. Potter: A RESOLUTION TO INCREASE THE SALARIES OF ALL TOWNSHIP PERSONNEL, OTHER THAN ELECTED OFFICIALS, BY 5%, EFFECTIVE JANUARY 1, 2025. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-02 WAS ADOPTED.
- Mr. Stubbs introduced RESOLUTION 2025-03, seconded by Mr. Potter: A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ESTABLISH THE 2025 REVENUE BUDGET TOTALING \$3,413,241.00, SUCH BUDGET TO BE SUBMITTED TO THE MONTGOMERY COUNTY AUDITOR. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-03 WAS ADOPTED.
- Mr. Stubbs introduced RESOLUTION 2025-04, seconded by Mr. Potter: A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ESTABLISH THE 2025 PERMANENT APPROPRIATIONS TOTALING \$3,764,978.51, SUCH APPROPRIATIONS NOT TO EXCEED THE AMOUNTS OF THE 2025 OFFICIAL CERTIFICATE OF ESTIMATED RESOURCES ISSUED BY THE MONTGOMERY COUNTY AUDITOR. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-04 WAS ADOPTED.
- Mr. Stubbs introduced RESOLUTION 2025-05, seconded by Mr. Potter: A RESOLUTION TO CONTINUE EXISTING HEALTH BENEFITS IN 2025 FOR ALL FULL-TIME EMPLOYEES WHO WORK AT LEAST 30 HOURS PER WEEK, INCLUDING MEDICAL, DENTAL AND VISION INSURANCE. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-05 WAS ADOPTED.
- Mr. Stubbs introduced RESOLUTION 2025-06, seconded by Mr. Potter: A RESOLUTION TO CONTINUE THE FOLLOWING MISCELLANEOUS PAYMENTS FOR 2025: (1) \$1.00 PER YEAR RESERVE POLICE OFFICER HONORARIUM FOR OFFICER MUAYAD SHOKEH; (2) \$15.00 PER MEETING EXPENSE REIMBURSEMENT FOR ATTENDANCE BY REGULAR AND ALTERNATE MEMBERS AT ZONING COMMISSION AND BOARD OF ZONING APPEALS MEETINGS. - Mr. Stubbs introduced RESOLUTION 2025-07, seconded by Mr. Potter: A RESOLUTION TO ALLOCATE 2025 TRUSTEE AND FISCAL OFFICER SALARIES TO VARIOUS FUNDS TO REFLECT THE AMOUNT OF TIME EACH ELECTED OFFICIAL SPENDS ON BEHALF OF THESE FUNDS:
 - TRUSTEE CROSS 100% GENERAL FUND (#1000)
 - O TRUSTEE POTTER 50% GENERAL FUND (#1000), 50% GASOLINE TAX FUND (#2021)
 - TRUSTEE STUBBS 40% GENERAL FUND (#1000), 50% POLICE DISTRICT FUND (#2081), 10% GARBAGE AND WASTE DISPOSAL DISTRICT FUND (#2071)
 - FISCAL OFFICER HEISTAND 40% GENERAL FUND (#1000), 25% GASOLINE TAX FUND (#2021), 25% POLICE DISTRICT FUND (#2081), 10% GARBAGE AND WASTE DISPOSAL DISTRICT FUND (#2071).

Mr. Stubbs introduced RESOLUTION 2025-08, seconded by Mr. Potter: A RESOLUTION TO CONTINUE 2025 DIRECT DEPOSIT FOR EMPLOYEES AND TO AUTHORIZE PAYMENT OF PAYROLL WITHHOLDINGS AND OTHER VENDOR PAYMENTS BY ELECTRONIC TRANSFER, INCLUDING USE OF THE FIRST NATIONAL BANK OF GERMANTOWN ON-LINE BILL PAYMENT SYSTEM. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-08 WAS ADOPTED.

- Mr. Stubbs introduced RESOLUTION 2025-09 seconded by Mr. Potter: A RESOLUTION TO ALLOCATE 2025 MONTHLY INTEREST TO THE SUNSBURY CEMETERY PERPETUAL CARE FUND (#4951) AND THE FOUTS TRUST FUND (#9752), AS ALLOWED BY THE STATE OF OHIO, BASED ON EACH FUND'S PRO-RATA MONTH-END BALANCE. The roll was taken and the adoption vote was as follows: Mr. Stubbs-Yes; Dr. Cross-Yes; Mr. Potter-Yes. RESOLUTION 2025-09 WAS ADOPTED.
- Mr. Stubbs made a MOTION, seconded by Mr. Potter, to approve the 15th and last day of the month, or if either fall on a weekend or a holiday, the last normal business day prior, as payday for employees of German Township during 2025. The MOTION WAS APPROVED by unanimous voice vote.
