- Dr. Cross introduced RESOLUTION 2023-45, seconded by Mr. Stubbs: A RESOLUTION APPOINTING SERGEANT CHRISTOPHER "SHANE" BIRCH TO THE POSITION OF INTERIM POLICE CHIEF OF GERMAN TOWNSHIP POLICE DEPARTMENT, EFFECTIVE 10/1/2023. Dr. Cross asked if this change in Sergeant Birch's titles would also result in a pay rate change.
- Dr. Cross made a MOTION, seconded by Mr. Potter, to table RESOLUTION 2023-45. The MOTION WAS APPROVED by a unanimous voice vote.

### **EXECUTIVE SESSION:**

- Dr. Cross made the following MOTION, seconded by Mr. Stubbs: I move to go into Executive Session pursuant to O.R.C. 121.22(G)(1) to consider the employment of a public employee. - The Trustees held discussion under the authority of O.R.C. 121.22(G)(1).
- At 4:15 pm Sergeant Christopher "Shane" Birch entered the Executive Session.
- At 4:23 pm, Dr. Cross made a MOTION, seconded by Mr. Stubbs, to reconvene into Regular Session. The MOTION WAS APPROVED by a unanimous voice vote.
