Overview

EnoTec is a wine tank management application designed for winemakers to track inventories, monitor SO_2 levels, and analyze volatile acidity trends. We are committed to protecting your privacy. This Privacy Policy explains what data EnoTec collects, how it is used, and your rights regarding your information.

The short version: EnoTec collects NO personal information. All your data stays on your device under your complete control.

Information Collection and Use

Data We DO NOT Collect

EnoTec does **not** collect, transmit, or store any of the following:

- **Personal Information**: No names, email addresses, phone numbers, or contact details
- **User Accounts**: No login credentials, usernames, or passwords
- **Location Data**: No GPS coordinates or location tracking
- **Usage Analytics**: No tracking of how you use the app
- Crash Reports: No automatic crash or diagnostic data collection
- **Advertising Data**: No advertising identifiers or tracking cookies
- **Device Information**: No collection of device identifiers, IP addresses, or hardware specifications
- **Network Activity**: The app does not connect to the internet or transmit any data

Data You Create and Control

EnoTec stores the following information **locally on your device only**:

- **Tank Inventory Data**: Tank names, types, volumes, and categories you create
- **Project Data**: Project names and associated worksheet information

- **Measurement Data**: SO₂ levels, volatile acidity measurements, and volume readings you enter
- **User Preferences**: App settings such as whether contextual tips are enabled

Important: All data is stored exclusively on your iOS device using standard iOS storage mechanisms (UserDefaults and local file storage). This data never leaves your device unless you explicitly choose to export it.

How Your Data is Stored

Local Storage Only

- All data remains on your device at all times
- EnoTec does **not** use cloud storage or sync services
- Your data is protected by your device's security features (passcode, Face ID, Touch ID)
- If you delete the app, all locally stored data is permanently removed from your device

Data Backup

- Your EnoTec data may be included in iOS device backups (iCloud or iTunes)
- You can manage backup settings through your iOS device settings
- Restoring your device from a backup will restore your EnoTec data

Data Sharing and Export

User-Controlled Export Only

EnoTec provides the ability to export your data in the following formats:

- **CSV Export**: Worksheet data exported as comma-separated values
- **PDF Export**: Trends analysis charts exported as PDF documents

Important: Data export is entirely user-initiated and controlled:

- You must explicitly tap the export button to generate these files
- Exported files are shared using iOS's native share sheet
- You choose where to send the data (email, files, other apps)
- We have no access to, knowledge of, or control over exported data

Third-Party Services

When you use the iOS share sheet to export data:

- The data is sent to services **you choose** (email, cloud storage, messaging apps, etc.)
- Those services have their own privacy policies
- Toki Studios is not responsible for how third-party services handle your exported data

TestFlight Beta Testing

If you are using EnoTec through Apple's TestFlight beta program:

- Apple collects usage data through TestFlight for beta testing purposes
- This may include crash logs, usage patterns, and device information
- TestFlight data collection is governed by Apple's Privacy Policy
- You can review TestFlight data collection in the TestFlight app settings
- Toki Studios may receive anonymized crash reports and feedback you submit through TestFlight
- Once EnoTec is released on the App Store, TestFlight data collection will no longer apply

Children's Privacy

EnoTec is intended for use by adults aged **18 years and older**. While the app contains no explicit references to alcohol consumption, it is designed as a professional tool for winemakers and winery operations.

Since EnoTec does not collect any personal information or user data, and all information is stored locally on the user's device, there are no privacy concerns related to minors beyond the age-appropriate use of a professional winemaking tool.

Data Security

Device-Level Security

Since all data is stored locally on your device:

- Your data is protected by your device's built-in security (passcode, biometric authentication)
- We recommend using a strong device passcode or biometric lock
- Enable "Find My iPhone" to remotely erase data if your device is lost or stolen

No Network Transmission

- EnoTec operates entirely offline
- No data is transmitted over the internet
- No risk of data interception during transmission
- No servers or databases that could be compromised

Your Rights and Choices

Complete Data Control

You have absolute control over your data:

- Access: All your data is accessible within the app at any time
- **Modification**: Edit or update your data whenever you want
- **Deletion**: Delete individual tanks, projects, or worksheets within the app
- **Complete Removal**: Deleting the app removes all data from your device
- **Export**: Export your data at any time in CSV or PDF format

User Preferences

You can control app behavior:

- Toggle contextual tips on/off via the lightbulb icon
- Manage tip display preferences through the welcome screen
- These preferences are stored locally and can be changed at any time

Changes to This Privacy Policy

We may update this Privacy Policy from time to time to reflect:

- Changes to the app's functionality
- Updates to legal requirements
- Improvements to our privacy practices

When we make changes:

- The "Effective Date" at the top will be updated
- Significant changes will be communicated through app update notes
- Continued use of EnoTec after changes constitutes acceptance of the updated policy

Data Retention

- **Active Data**: Stored on your device as long as you keep the app installed
- **Deleted Data**: Permanently removed when you delete tanks, projects, or the app
- **Exported Data**: Retention depends on where you save it (your email, files, etc.)

International Data Transfer

Since EnoTec stores all data locally on your device and does not transmit data over the internet:

- There are no international data transfers
- Your data stays in your physical possession
- No cross-border data transfer regulations apply

Third-Party Services

EnoTec does **not** integrate with any third-party services, including:

- Analytics platforms (Google Analytics, Firebase, etc.)
- Advertising networks
- Social media platforms
- Cloud storage providers
- Payment processors

The only external interaction is through iOS's native share sheet when you choose to export data, which is entirely under your control.
