3. Comments from the President
  - a. Approximately \$9,000 in the bank
  - b. For reference, May 2018-\$28,000
4. Approval of previous minutes
  - a. Emily motions to approve, Emilee seconds, approved unanimously
5. Financial/Budget Update

6. School Business
  - a. Review of toys and equipment
    - i. Con: Wooden blocks are a potential hazard

    - iii. Solution: Supervision might be the issue, possible solution could be to remove half of the bigger blocks to the shed until we have another teacher in the class
