Forwarded, you will see a date of June 28, 2024 for the Klauber appeal signed by Melanie Gray and emailed by William McCurine. The fee was paid by a check written by Kathleen MacLeod. Melane Gray was the concerned person who spoke on this matter at the CVCPG special meeting of June 17, 2024.

The appeal signed by Ms Gray matches, word for word, the appeal submitted by CVCPG on June, 25, 2024. June 25, 2024 is the date referenced in the Notice of Appeal. To my knowledge neither Melanie Gray, William McCurine, Kathleen Macleod, or CVCPG received notice of the September 17, 2024 Notice of Public Hearing on the appeal.
