- b) Public Safety Personnel Retirement System Local Board Report Office manager, Carmen Wailes reported that the PSPRS is rolling out a new payroll reporting system in 2026 and that Pine Strawberry has been selected to come down for a day of one-on-one training in December.
- c) Firefighter's Association Report Garrett Turley reported that the Association did get Breast Cancer Awareness T-shirts for the month of October, and the crews have been wearing them. The Association has also been helping get ready for the upcoming holiday events.

11) Old Business -

- a) Discussion and update on Bond Issuance Interim Chief Voakes reported that we are in a waiting period as far as the "votes" go. The last day to mail in ballots was Tuesday, October 28th. Any ballots after that must be driven to Payson and turned in. We won't know the outcome until November 4th or possibly even the 5th.
- b) Update/Discussion on future Station 41 Locations Interim Chief Voakes stated that originally the property we were looking at that belongs to the Fuller family was being discussed as a lease. The family has now decided that they would entertain selling off a portion of the land at a rate off 100K 200K per acre. So that is still a viable location for a new station. We do have a couple of other options as well.

- a) Discussion/Presentation RevGroup Representative, Phil Garace and Fire Truck Solutions representative Mark Julien were in attendance via zoom. Interim Chief Voakes explained that, just as we had done with the last engine we purchased, the building process began several years prior to the Engine being finished. The new Engine we are about to take delivery on began with a Letter of Intent in December of 2021. Because the process takes a few years, the Letter of Intent secures a build spot and current prices before the 4.5% increase.
- b) Discussion and possible action on authorizing the Fire Chief to send a 'Letter of Intent' to award purchase contract for a new fire engine. As discussed in the previous agenda item, the purpose of the 'Letter of Intent' is to secure current pricing and build spot during the building process of a new fire engine. Fire Truck Solutions rep, Mark Julien reiterated that he would not "hold your feet to the fire" should the Board decide that they do not wish to purchase a fire engine, but that the purpose of the letter is to allow them to secure a build spot and current prices.

Bob Bennett made a motion to authorize the Fire Chief to send a Letter of Intent to Fire Truck Solutions, LLC for the build of one E-One Custom Cab E-Max 4x4 Engine. Mel Palmer seconded the motion, and it passed unanimously.


