PINE-STRAWBERRY FIRE BOARD REGULAR MEETING MINUTES June 17, 2025

The meeting was called to order at 3:00 pm.

- 1) Pledge of Allegiance
- 2) Roll Call Present were Board Clerk Bob Papke, Member Bob Bennett, Member Dave Burkhart, and Member Melvin Palmer. Board Chairman Chuck Ackerman was absent.
- 3) **Presentations** None.
- 4) **Correspondence** Two letters of thanks were read.
- 5) Call to the Public –

Woody Phillips - The Pine-Strawberry Neighborhood Radio Watch reported that they now have radio communication with the volunteers at the Pine Brush Pit — which is significant because there is no cell phone service in that area. He again thanked the crews from the Fire District who helped to make this happen.

- 6) Approval of Previous Minutes
 - a) May 15, 2025 Regular Meeting Minutes Dave Burkhart made a motion to accept the minutes as written. Bob Bennett seconded the motion, and it passed with three ayes. Bob Papke abstained.
- 7) **Financial Report of April 2025** Ben Archer-Clowes of the James Vincent Group was in attendance and presented the financials for May. Mel Palmer made a motion to approve the financial report as given and to authorize the Board Clerk to sign. Dave Burkhart seconded the motion, and it passed unanimously. Training Report – Total training hours completed this month were 502 hours.

The Fire Marshal's Report – The Fire Marshal's office reviewed 3 sets of plans, adding 1,707 square feet of construction, and totaling \$407.10 of revenue.

Vehicle Report – 5 District vehicles were serviced this month for a total of \$15,890. Of that total, \$11,147 was for the completion of new Brush Truck B416. All District vehicles are currently in service.

10) Old Business -

a) Discussion and update on Bond Issuance – Chief Brandt reported that we are up to date with all the filings with Gila County for the Bond election. (More on this in item 11d.) No action taken.

11) New Business –

(Items to be considered, reviewed, discussed, and possible action on)

- a) Public Hearing for Fiscal Year 2026 Budget adoption Dave Burkhart made a motion to open a Public Hearing regarding the adoption of the proposed Fiscal Year 2026 budget. Bob Bennett seconded the motion, and it passed unanimously at 3:28 pm. (No comments from the public.)
 - Dave Burkhart made a motion to close the Public Hearing. Mel Palmer seconded the motion, and it passed unanimously at 3:29 pm.
- b) Discussion and Possible Action on adopting 2025/2026 Budget Dave Burkhart made a motion to adopt the 2025/2026 Budget as proposed with the 3.5% tax rate and authorize the Board Chairman and Board Clerk to sign it along with the State Form and submit to Gila County. Mel Palmer seconded the motion, and it passed unanimously.
- c) Discussion and Possible Action on PSPRS Pension Funding Policy Dave Burkhart made a motion to approve the PSPRS Pension Funding Policy and post it on our website. Bob Bennett seconded the motion, and it passed unanimously. (See website for PSPRS Pension Funding Policy under "Budget" section.)
- d) Discussion and Possible Action on Intergovernmental Agreement for Election Services Chief Brandt explained to the Board that an IGA is required with Gila County Elections Department for the Bond Issue. A rate sheet was provided to the Board members with the costs for a Special Election. Questions were raised as to whether this would be a "mail-in" vote or if we would have actual polling places set up. Chief Brandt said that is yet to be determined. Dave Burkhart made a motion to sign the IGA and submit it to Gila County. Mel Palmer seconded the vote, and it passed unanimously.
- e) Discussion and Possible Action on change to monthly Board Agenda to include "Prayer" -

Marilyn Bennett requested this item and requested the Board to consider this item. Marilyn stated that the Gila County Board of Supervisors begin their meetings with prayer. The United States House of Representatives and the United States Senate begin their meetings with prayer. Mrs. Bennett stated that a simple prayer could be read at the beginning of the meetings and provided a "sample" prayer.

The idea was discussed at length by all the Board Members. Ultimately, Dave Burkhart made a motion to add this as item #2 on the Agenda as "Invocation". Bob Bennett seconded the motion. Dave Burkhart, Bob Bennett, and Mel Palmer voted aye. Bob Papke voted No. Motion carried 3-1.

12) **Future Board Meeting Date** – Due to the summer AFDA conference, the next meeting date will be Thursday, July 24th, at 3:00. (Chief Brandt stated that he will not be here, but that he can have one of the Captains take his place.)



Fire Chief's Report - June 2025

Emergency Activity – Total Dispatches for May = 79 calls for service

Last month there were 55 calls for service.

Vehicle Report – 5 District vehicles had service done this month. T41 and T42 had their primers replaced. C41 had gasoline drained from its diesel tank. E41 had minor repairs completed and the new brush 416 had the bed fitted, the slip unit installed, upfitting completed, and graphics applied. \$15,890 was spent on vehicle maintenance this month \$11,147 of that was for the completion of B416, and all District vehicles are in service.

Training Report - Total training hours completed this month were 502 hours reported for all career members, and 69 hours reported for reserve members.

Plan Reviews – The PSFD Fire Marshall reviewed 3 sets of plans this month with a total addition of 1707 SQ FT. The total fees collected this month were a total of \$407.10.

- B416 is completed and will be ready for deployment by the end of the week.
