Generally, we assign your Request for Service to one of our field agents within 48 hours of receipt for Standard Service during a fourteen-day period unless you specifically request, and pay for, Expedited or Emergency Service.

A Verified Service Attempt is one where our Agent takes a photo, with its' meta-data showing Time, and GPS location, to verify their actual presence while at the listed service address.

STANDARD SERVICE

A Successful Verified Serve or; Up to three Verified Service Attempts within fourteen days of the receipt of the Request for Service.

EXPEDITED SERVICE

Assigned to a field agent within 24 hours A Successful Verified Serve or; Up to three Verified Service Attempts within Three Days of the receipt of the Request for Service.

EMERGENCY SERVICE

Immediately assigned to a field agent for Same Day Service or within 24 hours of receipt of Emergency Request for Service sent to us by 9AM EST.


