Terms of Sale By signing this Contract, Adopter and Breeder agree to the following:								

## **Breeder:**

- 1. The kitten is healthy to the best of the breeder's knowledge, has had all of the age appropriate vaccinations and deworming and is free of all internal and external parasites as confirmed by a licensed veterinarian at the time of adoption. Please keep in mind that young kittens may show signs of stress when brought into a new environment which may include sneezing, runny nose, watery eyes, diarrhea or constipation. These should resolve within a few days.
- 2. Breeder will provide a pet record from a licensed veterinarian listing all vaccinations, wormings, treatments (if any) and the dates thus far.
- 3. This kitten is guaranteed free of HCM and PKD.
- 4. The breeder guarantees for one year that if a fatal defect occurs as a result of a genetic or congenital defect the breeder will replace the kitten (less shipping charges and veterinary expenses). A necropsy report (at buyer's expense) from a licensed, board certified veterinarian is required.
- 5. Viral diseases (including Feline Infectious Peritonitis or FIP), parasites or bacterial infections are not covered by this health guarantee.
- 6. With all Ragdolls, coat and eye color change over time and can not be guaranteed to stay the same as the kitten grows.
- 7. Breeder reserves the right to null and void the contract at any time if so the deposit will be refunded.
- 8. RustsRagdolls reserves the right to hold a kitten back at any point and time.
- 9. Rustsaragdolls requires a \$300 deposit to reserve a kitten, deposits are non refundable and can be transferred to another kitten before a kitten is 10 weeks old and will not extend to another kitten more than 6 months.

## **Purchaser:**

- 1. The purchaser has 72 hours to take the kitten to their veterinarian for a well kitten visit if the buyer chooses not to; the contract is null and void.
- 2. These kittens are strictly indoor cats only. DO NOT ever expose your kitten to unknown outdoor cats/animals. Allowing your kitten outdoors where it may be exposed to diseases, fleas, ticks and parasites, voids the health guarantee.
- 3. The purchaser is responsible for ALL veterinary expenses incurred after acquiring kitten(s).
- 4. The purchaser will ensure that the kitten has the recommended routine vaccinations and wormings to maintain the health of the kitten.
- 5. The purchaser agrees to have the kitten spayed/neutered when at least 5 pounds and between 5-6 months for a male and 6 months for a female and no sooner.
- 6. Written proof of the neuter/spay from your vet is required if you want registration papers for your kitten(s).
- 7. If the breeder does not receive proof of the spay/neuter prior to the kitten reaching 7 months of age, TICA registration will be destroyed and the one year health guarantee will be revoked.
- 8. The purchaser is responsible for allergies, landlord issues and housetraining.
- 9. If you should no longer be able to keep your kitten, we will work with you to help you find a suitable home. **No refunds will be issued if you are not able to keep your kitten.** This kitten is not to be sold under any circumstances. If a kitten is found to have been sold or given away, the health guarantee is void and is not transferable.
- 10. Breeding of an unaltered RustsRagdoll kitten/cat without breeding rights is strictly prohibited. The breeder may elect to proceed with legal action if it is discovered that the adopter is breeding a RustsRagdoll cat. All legal proceedings will take place within the County and State of Breeder's residence.
- 11. By signing below the buyer agrees not to pursue any legal litigation, or threaten any legal action, against the breeder or post remarks of defamation or slander against the breeder or the breeders cattery.
- 12. Purchaser is required to instate the 30 day health insurance provided by Rusts Ragdolls within 24 hours of receiving the kitten. There is no cost to the purchaser. This contract is null and void if this is not activated.

## X - Obligation to Execute SpaySecure Agreement and Sterilize Pet

Buyer acknowledges that a) a material condition of this sale and transfer of this pet is a non-breeding animal, and b) that the pet is being sold to this Buyer in reliance on Buyers compliance with the obligation to sterilize the pet before the deadline set forth in their SpaySecure agreement. In so acknowledging, Buyer agrees to sign and comply with all terms of the SpaySecure sterilization agreement, to not breed the pet, and to take the pet to to a licensed veterinarian and have it surgically sterilized before the specific deadline set forth in their SpaySecure sterilization agreement.
