Physician's Letter & Immunizations - Upload -

Dated after March 1, 2025. Upload to child's profile. If most recent form is dated prior to March 1, 2025, upload it, however, a more current form must be re-uploaded no later than May 1, 2026. These are health department rules.

Required 5 question-form. Do ahead go to "forms"

CREDIT CARD required to check out to reserve your registration. If you prefer to pay by check, our office must assist you with registration. Due to the volume of registrations and inquiries on opening day we may not be able to assist you.

Do you have a family-level membership?

Your required membership must be current on registration day and *for the duration* of your child's program. Go to **hollyhillfarm.org** and click "Support Us"! You *cannot* purchase a membership on our summer registration site. For early registration day make sure you check all your email inboxes and make sure you haven't unsubscribed to our emails.

Current Physician Letter & Immunization Form

This is required to participate in programming. We are required by local and state laws to review and ensure all forms meet required dates and immunizations. Make sure you have a **recent digital copy** of your child's letter. If the letter you submitted is dated prior to March 1, 2025, you **MUST** re-submit a new more recent form no later than May 1, 2026. To resubmit go to you child's profile page, scroll to the bottom and you can upload a new form.

Emergency & Authorized Pick-Up Contacts

New families will be required to add emergency contacts along with authorized pick-up contacts. Existing families should review these for each child to ensure they are up to date. These can be updated and changed online by family at any time as needed.

Medical Form

Each parent will be prompted to complete a simple 5 question medical form that will assist our Education team. You can do this ahead by going to the "Form" menu once you are logged into your account. This form is required and if you submitted one more than 6 months ago you will be prompted to complete again. **If your child has an allergy** that requires EPI-Pen or inhaler, you will complete an additional permission to administer form by May 1, 2026 and no later than 5 days prior to your child's session.

IMPORTANT DATES

1/26/26 : Deadline to join or renew membership for early registration day

1/28/26: Membership must still be active on this date (i.e. does not expire until 1/29/26 or later) to receive early member registration day communications. Please note if your membership expires after you register, you must renew so it remains active through your child's program.

1/28/26 at 10:00 am : Early Member Registration Day check your email for special link and info. (Paste this link into your browser when and if you navigate off the secret Summer registration page)

1/29/26 at noon: General registration day
