1. Animal Interaction

Guests may be allowed to pet, groom, and feed animals.

Be aware that animals can and will bite! You may feed, pet, and groom the animals at your own risk.

2. Livestock Guardian Dog

Riverwatch Farm has one livestock guardian dog who is a working animal and should **not** be approached or petted at any time.

3. Restricted Areas

All visitors must remain at the barn and designated visitor areas. Please do not enter or approach any private residences or other non-visitor areas of Riverwatch Farm.

4. Farm Attire

Please wear old clothes and closed-toe shoes on the farm. This is a real farm—watch your step!

5. Photos & Videos

We often take photos or videos of visitors interacting with the animals. These photos may appear on our website, in published materials, and/or on social media.
