# **Business Meeting**

## **ITEMS DISCUSSED**

- Treasurers report approved.
- TLEEAA treasurer Joe Hawkins advised that he has completed the process to re-instate TLEEAA as a non-profit organization. This will allow the web site to return to normal status without being flagged. Status will need to be renewed on a yearly basis.
- Changing current email over to a business G-Mail system in order to cut costs. Costs will be about \$6 per person. Chris C. has begun the process of copying files and emails from the old system. Transition will occur in the new year.
- TLEEAA competition date set for July 27<sup>th</sup>-30<sup>th</sup>, waiting on contract to be finalized and signed by UTA. Due to increase in food and lodging since last competition, registration fees will need to be increased for participants (explorers/advisors) since the last competition. Projected cost will be \$300 per participant. Judges and actors who will be utilizing lodging and food will also see a price increase but that cost is still to be determined. Actors and judges who come in for the day both Friday and Saturday will be still able to eat lunch without cost. Motion to increase cost by Rebecca Woodward, seconded by Chris Grall, and Chris Cleveland. Rebecca W. reported that several agencies have already taken on scenarios and a few have expressed interest including agencies that have never hosted a scenario before.
- There has been a lot of new construction to UTA since the last TLEEAA competition, so it will be important for board members to be able to physically walk the campus in order to be familiar with logistics of the campus.
