

Chapter 2: Understanding the Precinct Leader Role

Precinct leaders are also referred to as

- "Precinct committee persons" in WCDCC bylaws
- "Democratic committeeman and Democratic committeewoman" on the primary ballots of even numbered years.

Precinct leaders are registered Democrats that are elected to a 2-year term by the Democratic voters of a precinct in the primary election (August of even-numbered years). Following reorganization, appointments may be made by the WCDCC Chair to fill vacancies for precinct leaders.

A Precinct Leader's Elected Duty

Precinct leaders are elected by the Democrats in their precinct in order to represent their voices in important votes.

After their election in August of even-numbered years, precinct leaders must attend the reorganization of the county party. At this meeting, the body traditionally votes to postpone reorganization until after the general election, so that reorganization does not affect campaign activity. Precinct leaders will then receive notice of the reorganization at least 10 days prior to the meeting. At this November meeting, precinct leaders will elect the chair, vice-chair, secretary, treasurer, and Sgt. of Arms of the county party, as well as vote on any bylaw changes. A copy of the bylaws can be found in the Appendix of this manual.

Precinct leaders are also responsible for voting for partisan offices should a vacancy arise. Replacements for members of the state house and state senate unable to complete their terms are elected by the precinct leaders residing in that district.

A Precinct Leader's Position in the Party's Structure

Precinct leaders are an integral part of the leadership structure of the Democratic Party at all levels and the Wyandotte County Democratic Party in particular. They are the face of the Democratic Party on a neighborhood level. Precinct leaders are vital for communicating information about the Democratic Party and for increasing voter turnout to help every Democratic candidate on the ballot on Election Day.

Each precinct leader automatically serves as a member of the Democratic Central Committee (DCC), which is the governing body of the WCDCC. On rare occasions, **key volunteers** in a precinct may be called upon to act as voting Proxy for the official precinct leader in your precinct. The Proxy must be a registered Democrat in that precinct and carry a written proxy assignment, dated and signed by the precinct leader and a third party.

The precinct leader is a publicly elected party official, elected by the Democratic voters of a precinct in the primary elections (in August of even-numbered years) to a two-year term. Precinct leaders must be registered Democrats in their precinct. Following reorganization, appointments may be made by the WCDCC Chair to fill vacancies for precinct leaders.

The Precinct Leader Role: Year-by-Year

Precinct leaders serve a crucial role in ensuring that Democrats are active during each election. In **odd years**, precinct leaders campaign in order to build the party. Though odd-year elections are nonpartisan, they provide a range of opportunities for our candidates: some find their niche for service early and maintain that position of public

service for years, while other serve, learn, and grow their resumé for higher office. We aspire to always have qualified Democrats to nominate for every level of public office. Municipal and county elections provide that opportunity. Since nonpartisan elections do not name the party of the candidate on the ballot, the Wyandotte County Democratic Party sees canvassing on behalf of Democrats running in these races as a service to our Democrats and an opportunity to build pride in our party.

Furthermore, the continuity of training, canvassing, and organizing in odd-numbered years gives time to teach the necessary skills to new precinct leaders and hone the skills of experienced leaders so we are even better prepared for future elections.

In **even years**, precinct leaders work for all of our candidates and voters. The importance of maintaining our base cannot be overstated. As such, precinct leaders in the Wyandotte County Democratic Party are asked to focus their canvassing efforts on Democrats. The forces whispering in Democratic ears about registering as Republicans for strategic voting depletes our numbers and discourages our potential candidates if we don't do the consistent work of reminding our Democrats what we stand for and how much we can accomplish together.

Not only does this encourage further participation by our Democratic base, but it also is crucial in recruiting and electing candidates. We offer a plan that will give dignity to our standard bearer candidates and a base to build on for our better financed candidates who have organized over a longer period of time.

Other Responsibilities of Precinct Leaders

• Sign the Agreement for Responsible Use of the VoteBuilder Database (see Ch. 7).

- Learn the Rules and Procedures of the Kansas Democratic Party (KDP) and the Wyandotte County Democratic Party (WCDCC). The KDP website (www.kansasdems.org) has a link to the PDF of the bylaws under the "About" tab.
- Recruit and organize the volunteers in the precinct.
- Gather information about and communicate with Democratic voters in the precinct.
- Disseminate information about voting and Democratic Party candidates to Democratic voters in the precinct.
- Work to increase voter turnout for Democratic candidates.
- Become a monthly contributor to the WCDCC.
- Participate/volunteer at WCDCC events and encourage voters to participate.
 - Community festival booths, parades, etc.
 - Fundraisers
 - 3rd Saturday Breakfast: 9:00 am (virtual until further notice)
 - Other events as posted on (wcdcc.com)
- Serve on Executive Board Committees.

Filing for Election to the Precinct Leader Position

Completed filing forms for Democratic Precinct Committee Members are accepted by the Wyandotte County Election Office only between January 1 and June 1 (noon) in even numbered years. The forms must be notarized. Historically, the Wyandotte County Democratic Party has made filing forms and notary service available at events during the open filing period, which also allows the party to track who has filed. You may file on your own at the Election Office, but as a courtesy, please let your Ward Captain know you have filed. There is no filing fee for this position.

When filling out the form, please ensure the following:

- The form is complete
- A daytime phone number is provided in case the Election Office needs to contact you regarding problems with your form
- On the form itself, please be sure to provide
 - Your name as it will appear on the ballot. It does not need to be the same as the name listed on your registration.
 - City or township
 - Your ward and precinct (these may be verified using the <u>maps</u> tool on the Wyandotte County Election website).
 - The party nomination sought: Democratic.
 - o The election year, which is the year in which you are filing.
 - You must check either "Committeeman" or "Committeewoman." The filing will be disqualified if you do not.
- Wait to sign and date the form until the notary witnesses your signature. Your signature is what they are "attesting to."
 - Please offer your driver's license or other photo ID to the notary for verification. Any notary must ask for your identification unless you are very well known to them. It is less awkward for our volunteer notaries if you are proactive, and offer your ID rather than making them ask for it.

It is important for precinct leaders to inform the Democrats in their precinct which candidates are Democrats. These local elections are important for "building our bench" for higher offices. The term "at-large" means the candidate is elected by the entire voting membership, instead of a subset of voters that represent a sub-district or ward.

Chapter 4: Voter Registration

The registration and voting process can be confusing and intimidating for new voters. Precinct leaders play an important role in both building our voting base as a party and encouraging new voters by demystifying this process. Voter registration can be conducted at events or while canvassing. When knocking on the doors of registered Democrats, you may encounter the following opportunities for voter registration:

- A new resident who is unregistered or needs to update their address to vote.
- Family members in the household who are unregistered (maybe turning 18 before Election Day)
- A resident who needs to update their registration information, such as name, address, or party affiliation.

For anyone who is unsure of their voter registration status or information, please use the "<u>Voter View</u>" tool on the <u>Wyandotte County Elections Office website</u>. It will ask for their name and date of birth to access their voter registration information. You may want to bookmark this link in your phone's browser.

General Instructions for Voter Registration

The registration form can be found here or in the Appendix of this manual.

All applications must be submitted at least 21 days prior to Election Day. Applications may personally delivered, or mailed to the election office:

Wyandotte County Election Office 850 State Ave Kansas City, KS 66101

Make sure the applicant marks the 2 boxes in the upper left-hand corner of the form regarding eligibility for voting. Those boxes ask if they are a citizen of the United States and if they are at least eighteen years of age. Both questions are notated by boxes marked "Yes" and "No." In order to complete the application, "Yes" must be checked for both questions.

Box 5: Make sure they include a phone number so that

- 1. The Election Office can call them if they can't read their handwriting or have other questions to complete the registration
- 2. If they register as Democrats, we will have access to their phone number in VoteBuilder

Box 6: The ID number can be the last 4 digits of the Social Security number or their driver's license number.

Box 7: It is important that people who vote for Democrats register with the Democratic Party (see letter in Appendix). A good way to encourage applicants to choose a party is to remind them that they will not be allowed to vote in partisan primary elections unless they have chosen a party. There is no Independent Party in Kansas. The only options are Democrat, Republican, or Libertarian. They will be registered as Unaffiliated if this box is left blank.

Box 8: Race or Ethnic Group can be left blank. This information is not collected in Kansas.

Double-check the application to see if it's complete and legible. To help ensure that the form is submitted, you can offer to save them a stamp by delivering it to the Election Office for them. By law, a third party has 5 calendar days from the date of the applicant's signature to deliver it.

Address or Name Change

If a person changes their address or any part of their legal name, they must update that information prior to voting. They should fill out the <u>federal voter registration form</u> and include their old information on the bottom half of the form: Section A for old name and/or Section B for old address, including county. If they were registered in Kansas prior to January 1, 2013, or previously submitted proof of citizenship, the inclusion of their old registration information will ensure they will not need to provide proof of citizenship again.

Voting Eligibility of Individuals with a Felony Charge

People who have been convicted of a felony are eligible to vote once they have completed their parole or probation (when they are "off papers").



Online Voter Registration

There is a digital option for voter registration that is very simple to use. It uses the federal registration form and is reported to equal the success rate of using paper forms. The same questions and guidelines above apply. Save the KSVotes link (https://ksvotes.org/) to your phone for easy access while canvassing.



Private Browsing

Use an Incognito (Chrome), Private Browsing (Safari), Private (Firefox), or InPrivate (Edge) tab/window when sharing your device to register voters. This will keep any previously saved information (including your own!) from pre-populating the form fields, and will keep their information from being saved by the browser.

Chapter 5: Advance Voting & Advance Ballot Application

Advance voting increases voter turnout by making it more convenient to vote and allows the Democratic Party to track voter numbers, which reduces the work that must be done on Election Day.

There are two types of advance voting:

- 1. Advance voting in person, which does not require an application. This is available Monday through Saturday at 3 locations in Wyandotte County the week before the election. Final details are published on wycokck.org/election in advance of each election.
- Advance voting by mail, which requires an Application for Advance Voting Ballot (see Appendix). These applications need to be filled out for each election (primary and general elections require separate applications).

Precinct leaders should encourage voters who support Democratic candidates to vote in advance and offer them applications for advance voting by mail. Voters who will be out of town during the election (college students, for example) can have a ballot mailed to them wherever they are by listing a mailing address that is different from what is on their voter registration.

Guidelines for Advance Voting by Mail

Applications must be submitted to the county election office via mail (Wyandotte County Election Office, 850 State Ave, Kansas City, KS 66101)or hand delivery within 48 hours of the signature date on the application.

Completed applications must be received at the election office before 5pm on the Tuesday prior to the election and can be submitted as early as January 1 of the same calendar year as the election.

Ballots will be mailed to the voter starting 20 days prior to Election Day. Voters should be alert to look for them, and return them promptly.

Voters may submit their ballot by mail or hand deliver it to any polling place before 7pm on Election Day (new in 2017).

Please remind voters that they must sign the ballot envelope and put only one ballot in each envelope. Ballot envelopes that do not have a signature and address will not be counted. Putting more than one ballot in an envelope will also prevent the ballots from being counted. The signature will be compared to the signature on the voter registration card that is on file at the election office.

Uniformed and overseas citizens who wish to vote by absentee ballot must submit an application for the Federal Services Ballot to their county election office at least 45 days prior to Election Day.

Chapter 6: Canvassing

Goals of Canvassing

- 1. Get to know the members of our party and gather important information. Every canvass list will come with a script that includes survey questions. **Make sure all answers are clearly recorded.**
- 2. Disseminate information about candidates, Democratic Party events, and volunteer opportunities.
- 3. Increase voter turnout. The more voters feel connected to the Partyand informed about the election, the more likely they will vote.

Why knocking on doors is important

According to research, knocking on doors is a very effective and low-cost method to increase voter turnout. Compared to a phone call, voters develop a stronger connection to the Party when they talk with someone from their neighborhood face-to-face. Also, with changes in technology, many people are more likely to answer their door than their phone.

Canvassing Best Practices

Best Times To Canvass

1. General best practice:

Monday-Thursday from 5-8pm Saturday 10am-5pm, and Sunday

2. Know Your Precinct

Every turf is different. If you have a turf with a large number of retirementage voters, for example, then 10am to 5pm may work weekdays as well. If you catch folks out in the yard on a warm Friday evening, that can be a good time for a canvass.

If you are able to talk to someone at 20% of the houses on your list, that is a good result!

Supplies for Canvassing

- 1. A binder that contains:
 - a. Turf list & map
 - b. Script with survey questions
 - c. Candidate literature distributed by Ward Captians or the WCDCC
 - d. Information about Democratic party events
 - e. Federal voter registration forms
 - f. Advance ballot applications
- 2. Extra pen
- 3. Painter's tape or plastic bags for leaving literature if no one answers the door
- 4. Water bottle
- 5. Smartphone or tablet, if using MiniVan

Safety

While you will find many of your encounters at the door gratifying and rewarding, it is still important to exercise caution when canvassing. To that end, always step back from the door after knocking. This not only makes you appear less threatening, but also reduces the threat to yourself from wayward screen doors or animals who may be excited by your presence.

Much of our canvassing occurs during the summer months, and in Kansas it can get **hot**. Keep yourself hydrated and take breaks to ensure you aren't hurting yourself. If there is a

heat advisory, push your canvassing to another day! If you are canvassing on a hot day, people may invite you inside for the air conditioning or for water. If you know them, go for it. If not, stay outside.

"No Soliciting" Signs

- Precinct leaders should become familiar with city ordinances.
- Many neighborhoods have these signs on almost every door, so skipping these
 houses is a barrier to achieving good results. Furthermore, many of the signs
 were probably put up by previous owners.
- If you always introduce yourself as a volunteer, it puts many people at ease quickly.
- If the homeowner is upset, even after learning that you are a volunteer who's not selling anything, simply apologize and leave quickly. Remember, precinct leaders are the face of the Democratic Party in Wyandotte County. We need to remain professional and respectful at all times. Please make note of the encounter on your turf list to prevent others from knocking on the same residence. They can be marked "Don't Walk" in the database.
- If you feel uncomfortable knocking on a door for any reason, we respect your
 decision to skp it. You will, however, want to implement an alternate plan for
 contacting that voter (phone call, snail mail, email) including asking them our
 survey questions and establishing an acceptable way to deliver any literature you
 have for them.

Chapter 7: Setting Goals

It has been said that "all politics is local." The most meaningful goals will be the ones that you set for your own precinct.

1. Specific

Consider the who, what, when, where, and why of each goal.

2. Measurable

Include numbers in your goal, such as the number of doors knocked, or the number of people asked to volunteer.

3. Attainable

Don't set goals for things that are out of your control. For example, you can control the number of people you invite to a Democratic event, but you can't control how many people attend the event.

4. Realistic

Set your goal in a way that will stretch yourself, but isn't out of reach. Consider the number of volunteers you have and the number of hours per week you can devote.

5. Timely

Utilize timelines to stay on track. Set short-term goals with deadlines (weekly or monthly) that will lead toward long-term goals for Election Day.

Examples of short-term goals:

- ★ I will develop a literature drop for my precinct by April 1.
- ★ I will knock on every door of one turf list for my precinct every 2 weeks.
- ★ I will submit the data for each turf list I complete within 5 days of completion.
- ★ I will discuss volunteer opportunities with 6 Democrats in my precinct by May 1.

Examples of long-term goals:

- ★ I will attempt 2 contacts with every Democrat in my precinct before the November election.
- ★ I will attend every Senate District meeting this election cycle.

Chapter 8: Recording Canvassing Data

As mentioned in Chapter 6, knocking on doors is an effective way to increase voter turnout, not only because of the human contact, but also because of the data we collect which allows us to follow up with voters to ensure they vote.

Your Senate District leader or Data Captain will send you your turf lists via email. You should push yourself to canvass these lists **as soon as possible** after you've received them. You canvass using two methods: recording data on paper, and recording data through MiniVan.

Canvassing with Paper Lists

Paper lists are printed versions of the turf lists sent to you by your Senate District leader or Data Captain. They include information on all of the Democratic voters in a certain geographic area of your precinct, and have places to mark their responses to survey questions.

Canvassing with MiniVan

MiniVan is a helpful tool that allows you to canvass lists given to you by your Senate District leader or data captain using a smartphone or tablet. It syncs the data you collect with VoteBuilder directly, so there is no need to go back and enter the data manually.

Before you are given a list, you will need to complete and sign the Responsible Use Agreement for VoteBuilder, shown here an in the appendix.

If given direct access to the database, the precinct committee member or key volunteer:

Will seek training and ask questions of Ward Captains or the Executive Board to avoid any inadvertent mistakes in recording of data.
Will use the database only for the work of the Wyandotte County Democratic Central Committee
If given printed or pdf lists generated by VoteBuilder database, the precinct leader or key volunteer:
Will protect the list and not allow unauthorized use
Will seek training and asks questions of Ward Captains or the Executive Board to avoid any inadvertent mistakes in recording of data.
Will use the database only for the work of the Wyandotte County Democratic Central Committee.
Will return lists to the designated person at the end of the project
