#### CALL TO ORDER

Sheri Shepard called the meeting to order.

### **COMMITTEE REPORTS**

The Landscape Advisor Committee provided a report.

### **CONSENT CALENDAR**

Gretia Capri made a motion to approve the Consent Calendar of minutes for June 12, 2024. Jim Sterken seconded the motion. The motion was unanimously approved.

#### **OLD BUSINESS**

Gym Remodel – Gretia Capri. The gym remodel is in progress flooring to be delivered next week and installed; once that is completed the baseboards will be installed and equipment return for operation.

Security Front Entrance – Ken Van Osdol reported that the Safety and Security Committee has been working diligently proceed with the Virtual Guard contract and with the Civil Engineer on the development of the additional lane for an owner's entrance. The Civil Engineer as revealed a concern with the storm drain so the committee is looking to phase the work with getting Virtual Guard contract executed. This will permit the committee to continue to work on the development of the metal swing arm gates installation and the Civil Engineer to continue to develop the plan for the additional lane while the gate remains operational and manned virtually. The new plan will permit the owner five different manners to access the community through the gate 1) owner will have a RFID tag on the front of the vehicle; 2) the implementation of a license plate reader to capture the back of the vehicle; 3) an apply on your smart phone; 4) a time restricted code, and 5) push the button and speak with the guard.to develop a plan for a new security system at the front gate to replace our current manned guard system. The goal is to have the Virtual Guard in place by September 1<sup>st</sup>.

Bid Resolution on contracts in excess of \$50,000 – Jim Sterken made a motion to approve the bid resolution. Sheri Shepard seconded the motion. After discussion, the resolution was revised to state contracts with a value in excess of \$50,000. The motion was unanimously approved.
