The Davidson County Board of Elections met on Thursday, November 16, 2023 at 6:00 p.m. in the Board of Elections office located at 945 N. Main Street, Suite A, Lexington, North Carolina 27292.

Mr. Cunningham called the meeting to order at 6:00 p.m. with the following members present: Belinda Clark, Kathy Hunt, Chad Freeman, and Richard Johnson. Director Andrew Richards and Deputy Director Adam Moore were present. There was one visitor present.

Ms. Clark read the minutes from the November 7, 2023 board meeting. Mr. Freeman made a motion to accept the minutes and seconded by Mr. Johnson. It was unanimously approved.

Director Andrew Richards presented the board with 4 Civilian Absentee Ballots recommended for approval for the November 7, 2023 Municipal Elections. After review, Mr. Freeman made a motion to approve the 4 Civilian Absentee Ballots and was seconded by Ms. Clark. It was unanimously approved.

Director Andrew Richards presented the board with 1 Civilian Absentee Ballot not recommended for approval due to its arrival after Election Day with no postmark. Deputy Director Moore ran the tabulation for the Supplemental Absentee Ballots. Ms. Hunt made a motion to accept the tabulation and was seconded by Mr. Johnson. It was unanimously approved and each board member signed the tabulation tape.

Director Andrew Richards presented the board with 13 Provisional Ballots recommended for approval. After review, Mr. Freeman made a motion to accept the 13 Provisional Ballots and was seconded by Ms. Hunt. It was unanimously approved.

Deputy Director Adam Moore presented the board with 23 Provisional Ballots recommended for disapproval. After review, Mr. Freeman made a motion to reject the 23 Provisional Ballots and was seconded by Ms. Clark. It was unanimously approved.

Deputy Director Adam Moore presented the board with the zero tape for the Provisional Tabulation. Each board member signed the tape. Deputy Director Moore ran the tabulation for the Provisional Ballots. Mr. Freeman made a motion to accept the tabulation of the Provisional Ballots and was seconded by Mr. Johnson. It was unanimously approved and each board members signed the tabulation tape.

Director Andrew Richards presented the board with the Supplemental Absentee Abstract. Each board members signed the abstract and it was properly notarized.
