Georgia PSC to the rescue?

Earlier this month, the Georgia Public Service Commission (PSC) held a hearing on a group of landowners seeking to overturn a decision made by a court earlier this year, that would allow Sandersville Railroad Co. to acquire their land through condemnation. The company plans to install a 4.5-mile line through one of Georgia's poorest counties, Hancock, in an effort to connect manufacturing facilities with the CSX Transporation main line (www.georgiarecorder.com).



The PSC heard oral arguments from both landowners and the railroad company on August 6th. This could have large ramifications regarding eminent domain going forward. The community group alleging that the railroad company has not met the requirements of Georgia's Eminent Domain law, proving that the desired land is required for their business purposes. Bill Maurer, counsel representing the landowners, simply states, "This is not just a question of our evidence versus their evidence. Instead, the railroad has failed to show either the most basic facts that this project constitutes a public use or is necessary to their business." The Sandersville Railroad Co. claims that the new line will provide transportation to small farmers and business alike bringing new economic growth thus fulfilling the public necessity. The PSC is set to make a decision in the coming months.
