Town of Aberdeen 115 N Poplar St 910-944-1115	Must be outside street right-of-way, or at least 6 ft from edge of pavement; Not in public street medians or traffic islands; Not interfere or obstruct safe sight distances at intersections; Not on private land without consent of owner; Not to exceed 16 sq ft, max height of 6 ft; One sign per candidate for each street frontage	30 days prior to the beginning date of "one-stop" early voting removed w/in 7 days after an election.
Town of Cameron 247 Carter St 910-245-3212	Must be outside street right-of-way, or at least 3ft from edge of the pavement. No closer than 100 ft apart. Shall not interfere or obstruct sight distances at intersections. Not to be placed on private property without consent. May not exceed 6 sqft, max height of 4ft.	30 days prior to the beginning date of "one-stop" early voting removed w/in 5 days after an election.
Town of Carthage 4396 15-501 Hwy 910-947-2331	All signs must be outside street right-of-way, or at least 3 feet from the edge of the pavement. Signs shall not interfere/obstruct safe sight distances at intersections. Not to be placed on private property without consent of owner. Must not exceed 16 sq.ft, max 6 ft high. Cannot be placed until 30 days prior to start of One Stop. May be placed 30 days prior to run-off election or election day following a primary and removed again within 10 days after election run-off.	30 days prior to start date of One-Stop voting/ 10th day after primary or election day.
Foxfire Village 2145 Foxfire Rd, ste 12 910-295-5107	Not to exceed 18 sq ft	30 days / 5 days
Town of Pinebluff 325 E Baltimore Ave 910-281-3124	Not to exceed 16 sq ft	30 days / 3 days
Village of Pinehurst 395 Magnolia Rd 910-295-1900	Signs for political candidates, parties, or groups supporting the candidacy of any individual for office or encouraging public support of or opposition to any public issues to be voted upon are permitted provided that: Maximum area is 6 sq.ft. Maximum Height is 4 feet. Signs must be self supporting and not attached to any structure. Must also have a setback from edge of pavement of 3 feet. NO ELECTION SIGNAGE IS ALLOWED TO BE DISPLAYED AT ANY VILLAGE OF PINEHURST POLLING LOCATIONS UNTIL ELECTION DAY.	30 days prior to beginning date of "one-stop" voting under NCGS § 163-166.40. Must be removed 7 days after the election.
Town of Robbins 101 N Middleton St 910-948-2431	Not to exceed 32 sq ft in area; private property only	30 days prior to "One Stop voting" / 7 days
Town of Southern Pines 125 SE Broad St 910-692-7021	30 days before the beginning date of early voting for a primary, general, or special election, an unlimited number of signs may be placed on private property. The maximum allowable Sign area of each such Sign shall be six (6) square feet. Each Sign shall be located on private property but in no case shall a sign be allowed closer than ten (10) feet to the paved portion of a road or ten (10) feet from the edge of the travel portion of a non-paved road and may not be attached to a tree or other living plant material. Such Signs must be removed within ten (10) days following the election day for which the Signs are intended to serve. If the period of time between a primary and a general or special election for which the primary is serving is less than four (4) weeks, measured from the date of the primary voting day to the date of the general or special election voting day, the Signs shall be allowed to remain in place. Such Signs may be erected at officially designated polling places on the day of the election.	30 days prior to early voting / 10 days
